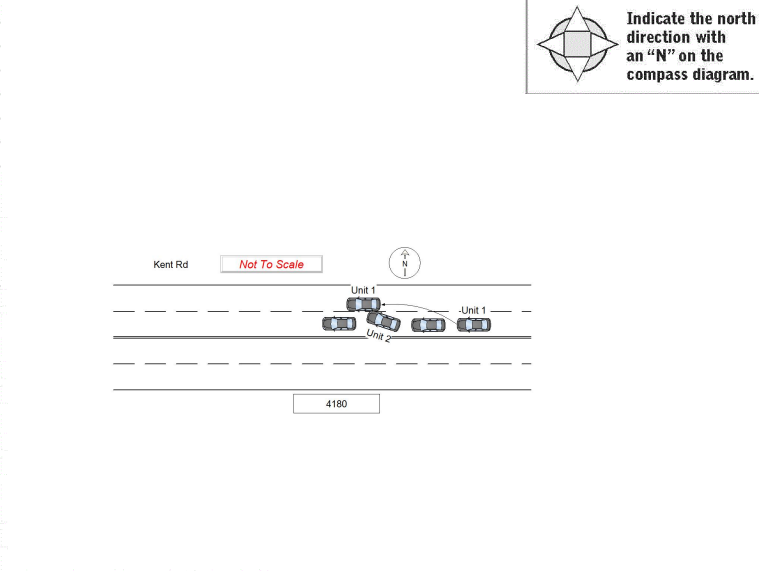

Unit 1 states unit 2 merged into the right lane and struck the car. Unit 2 states unit 1 cut unit 2 off and struck the car. Prosecution declined due to conflicting statements.

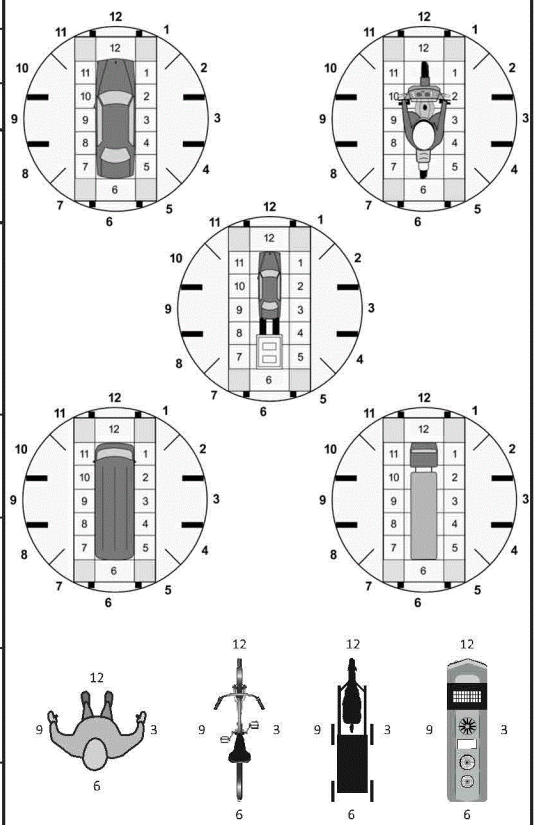
