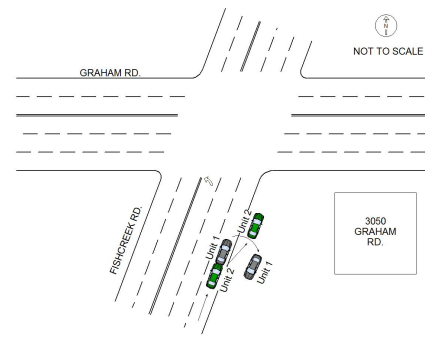
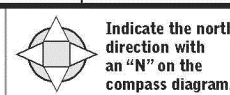

UNIT #1 WAS TRAVELING NORTHBOUND ON FISHCREEK RD NEAR GRAHAM RD IN THE RIGHT LANE. UNIT #2 WAS TRAVELING DIRECTLY BEHIND UNIT #1. UNIT #1 SLOWED TO MAKE A RIGHT TURN INTO THE LOT OF 3050 GRAHAM RD. UNIT #2 FAILED TO MAINTAIN A CLEAR AND ASSURED DISTANCE, STRIKING UNIT #1 TO THE REAR. UNIT #1 AND UNIT #2 RAN OFF THE ROAD RIGHT. THE FRONT LEFT TIRE OF UNIT #1 WAS POPPED DURING THE INCIDENT.

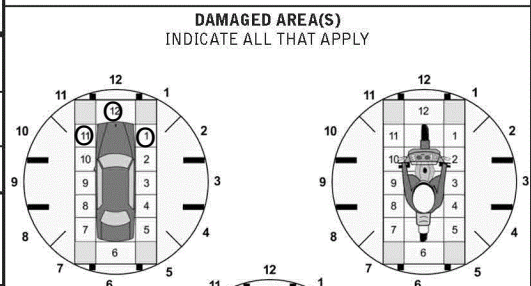

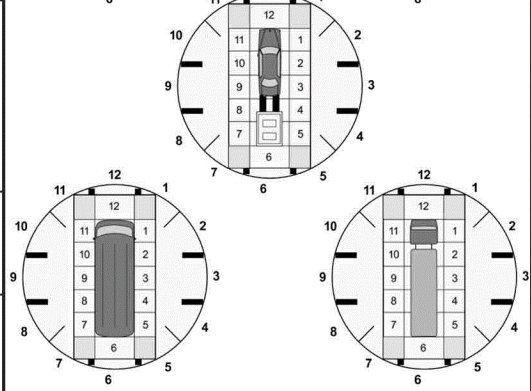

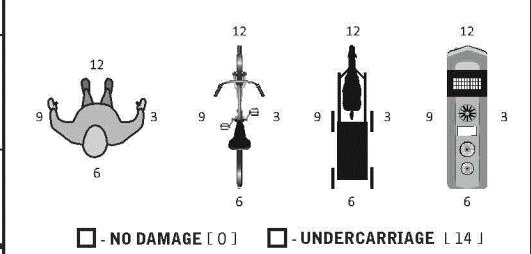
