Unit 1 was headed westbound on Arndale Road. Unit 1 pulled into a driveway. Unit 1 hit an electrical pole in the driveway.

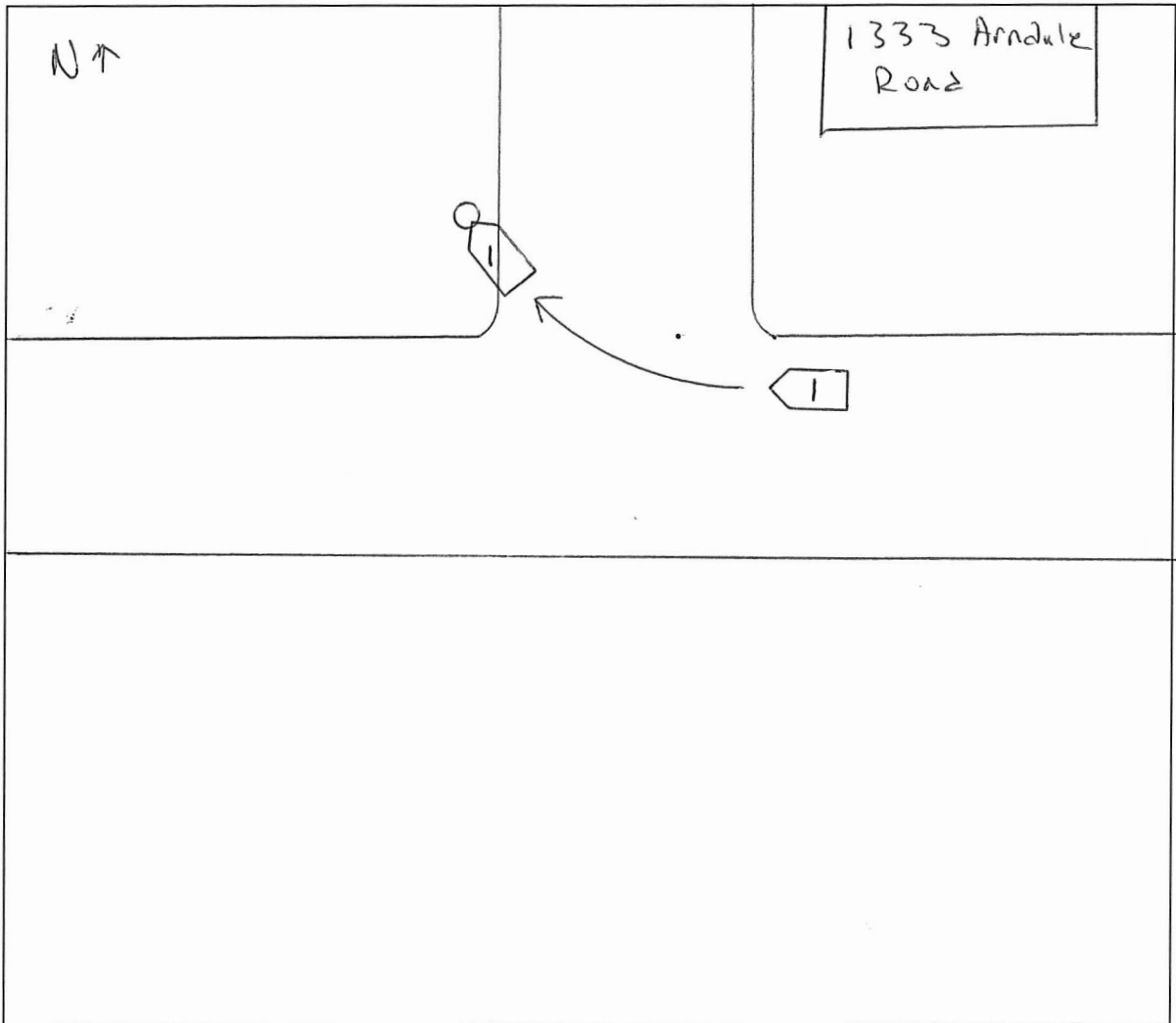
