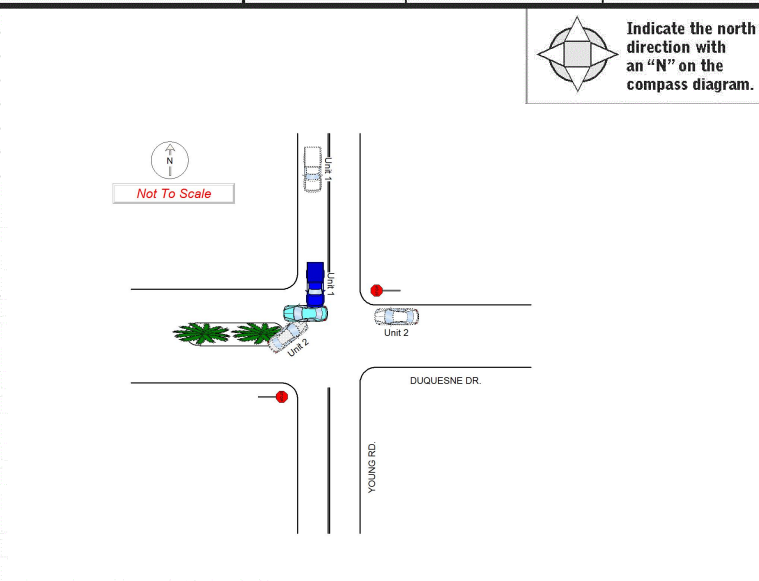

Unit #1 was southbound on Young Rd. Unit #2 was westbound on Duquesne Dr. stopped at the Young Rd. stop sign. Unit #2 failed to yield to unit #1 and proceeded through the intersection to continue on Duquesne Dr. Unit #1 struck unit #2. The impact spun unit #2 partially around. Unit #2 subsequently struck a curb, a landscaping embankment, and a tree. Unit #2 was operating on a temporary driving permit without a valid driver in the vehicle.
