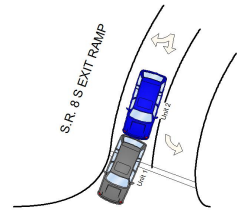
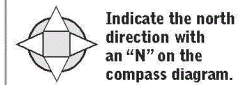

UNIT #1 WAS STOPPED IN TRAFFIC ON THE EXIT RAMP OF S.R. 8 SOUTH AT STEELS CORNERS RD. AT THE RED TRAFFIC LIGHT. UNIT #1 INCHED AHEAD TO GET A BETTER VIEW OF TRAFFIC AND THEN STOPPED AGAIN. UNIT #2 WAS DIRECTLY BEHIND UNIT #1. THE DRIVER STATED THAT WHEN UNIT #1 INCHED AHEAD, HE BELIEVED SHE COMPLETED HER TURN BUT DID NOT ACTUALLY ASSURE CLEAR DISTANCE AHEAD AND STRUCK THE REAR OF UNIT #1.
