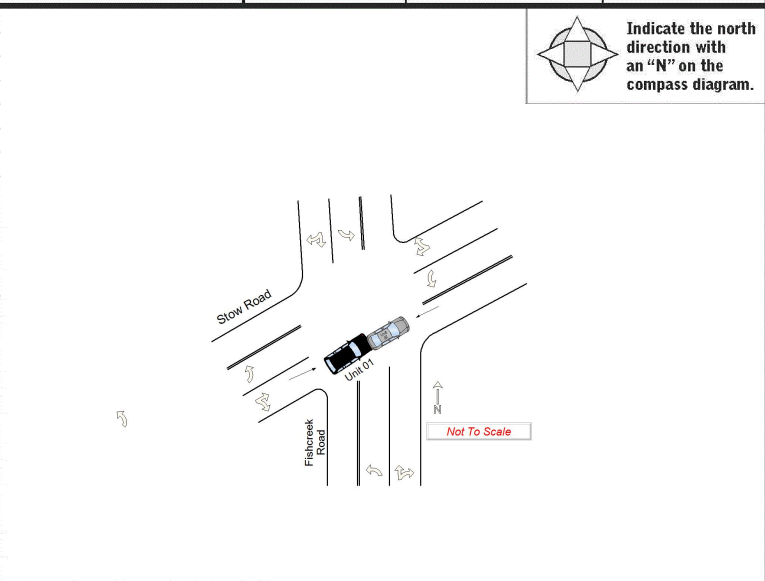

NARRATIVE

Unit 02 was traveling northbound on Stow Road through the intersection of Fishcreek Road with a green light. Unit 01 was traveling directly behind Unit 02. An unrelated vehicle ran the red light traveling northbound on Fishcreek, for a northbound turn onto Stow Road. This caused Unit 02 and Unit 01 to quickly brake. During this, Unit 02 accidentally placed the vehicle into reverse, and backing into Unit 01. The crash occurred in the middle of the intersection.
