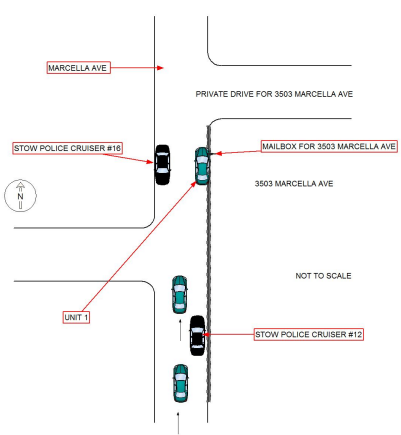

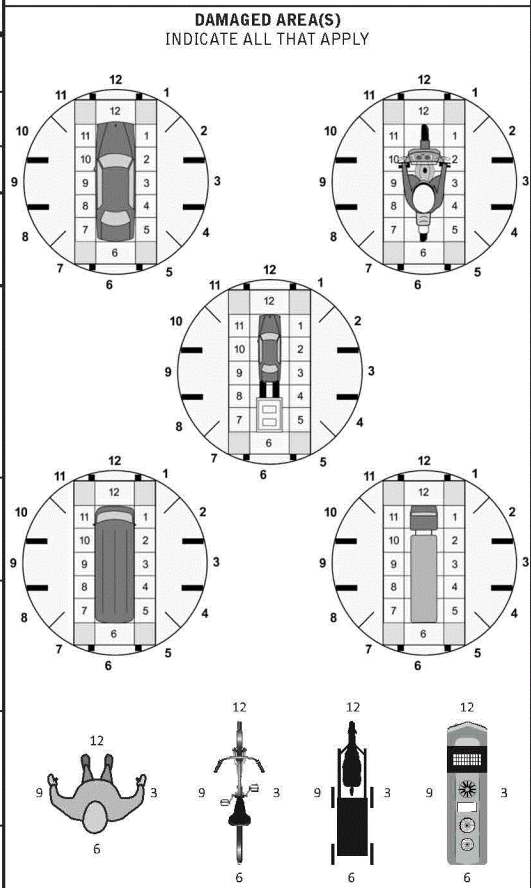

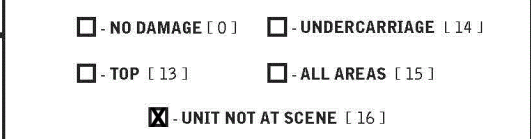

On Aug. 24, 2022 @ approximately 1324 hours, a green Subaru Forester was NB on Marcella Ave, went off the roadway to the right side and struck a mailbox at 3503 Marcella Ave and then left the area.

Myself and another SPD officer were handling a police matter across the street and had our marked patrol cars parked in the area as well.

My SPD cruiser, #12, caught the suspect vehicle on its MVR but the license plate could not be read clearly. A later attempt to retrieve video to make it more clear was unsuccessful.

The suspect vehicle was observed NB passing SPD cruiser #12 and then moving back into its lane NB. It appears the suspect vehicle then overcorrected while attempting to pass SPD cruiser #16 and went off the right side of the roadway at 3503 Marcella Ave where it struck the mailbox there.

The suspect vehicle then drove off EB on Kent Rd. Attempts to locate it were unsuccessful. I attempted to review the MVR of Car 12 but was unsuccessful in obtaining a clearer view of the suspect's LP. Several local Subaru Forester's were located via an investigation but none had any damage to link them to the hit/skip.

The mailbox was owned by Marwa Sadalla of 3503 Marcella Ave, Stow, OH 44224.
