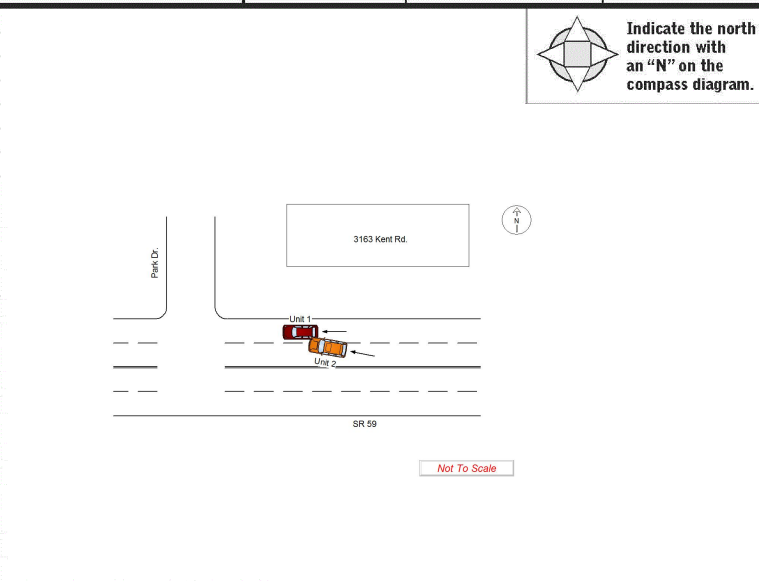

Unit 1 was traveling west on SR 59 approaching Park Dr. in the right lane. Unit 2 was traveling on SR 59 in the same direction in the left lane. As Unit 2 passed Unit 1, the driver of Unit 2 failed to stay within the marked lanes of travel, striking Unit 1 on the drivers side. Unit 2 did not stop after the accident but was identified and contacted after the accident thanks to witnesses.

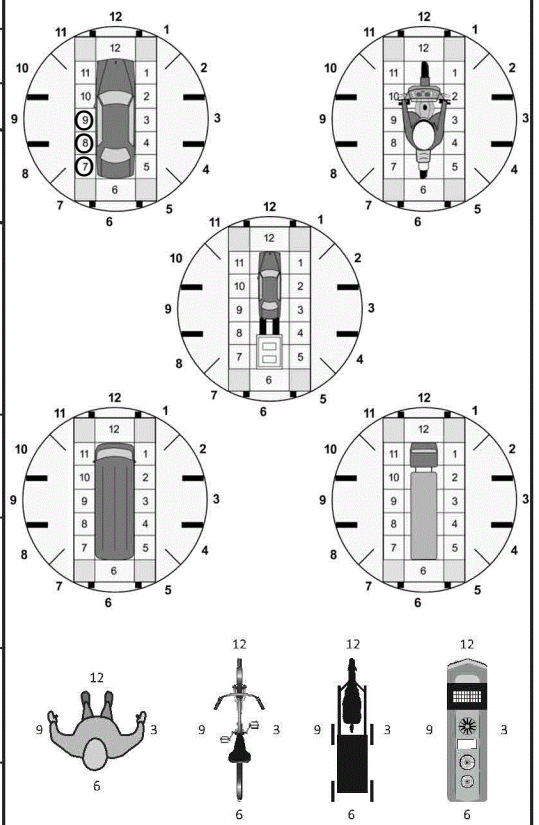

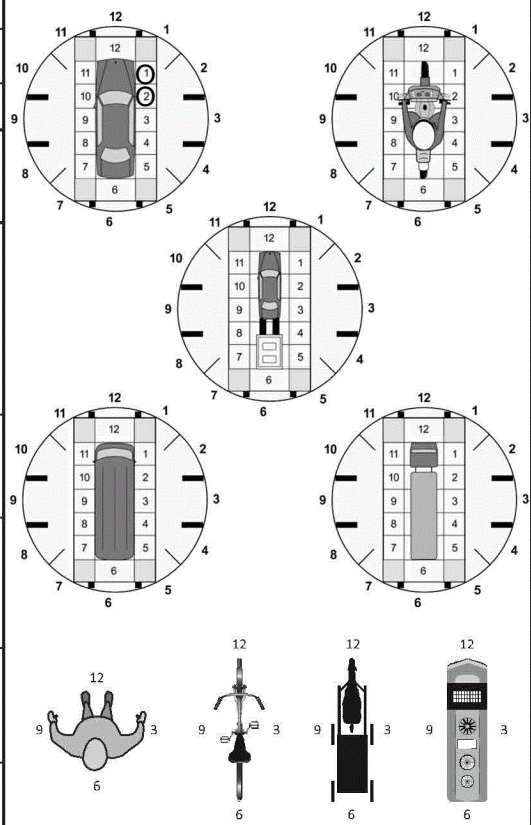
