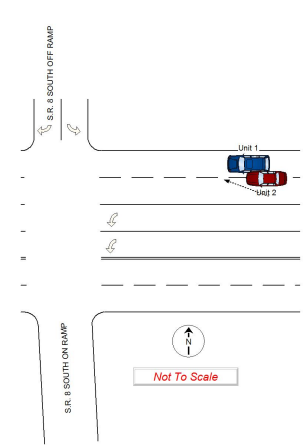
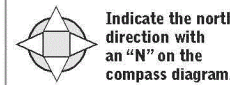

Unit #1 was traveling west on Steels Corners Rd. in the curb lane approaching the intersection of S.R. 8 South. Unit #2 was traveling beside Unit #1 and changed lanes suddenly without yielding to Unit 1, who had already maintained the curb lane. Unit #2 sideswiped Unit #1. The driver of unit #2 stated that a driver in the left turn lane started to enter her lane, startling her to make a sudden lane change without looking.

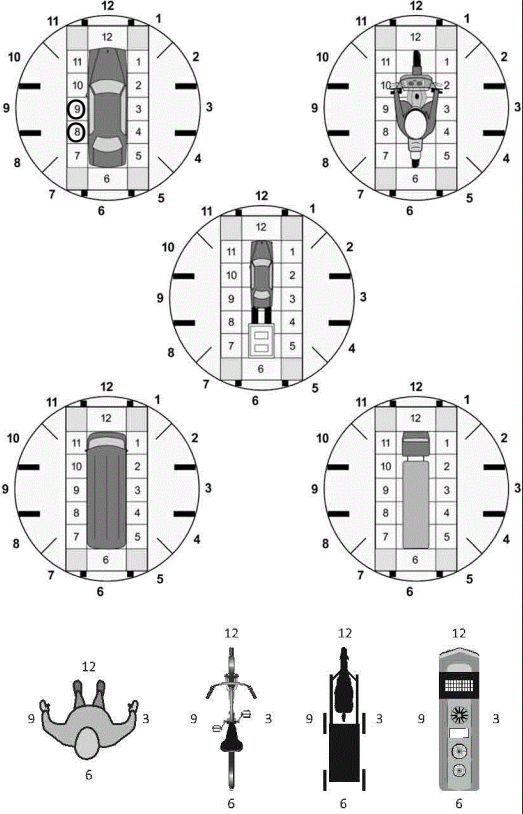
