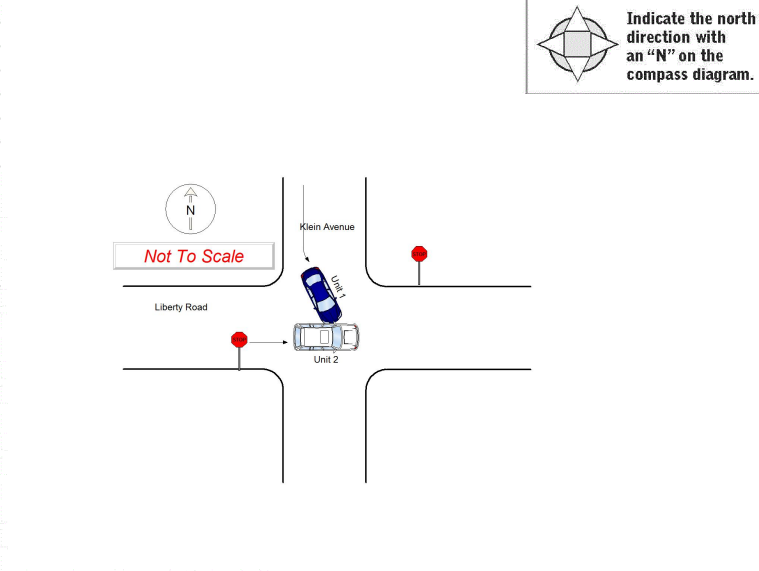

Unit 1 was s/b on Klein Avenue (and did not have a stop sign). Unit 2 was e/b on Liberty Road. Unit 2 stopped, but failed to yield to cross traffic, at the stop sign at Klein Avenue. Unit 1 broke suddenly and swerved in an attempt to avoid the collision with Unit 2, but the units collided within the intersection.

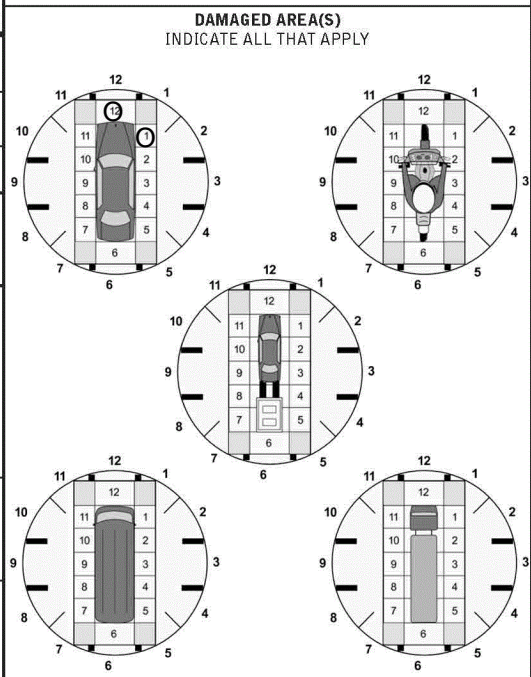
