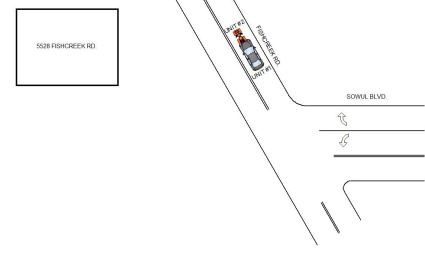

UNIT #1 WAS TRAVELING NORTHBOUND ON FISHCREEK RD. NEAR 5528 FISHCREEK RD.

UNIT #2 WAS STOPPED IN THE ROADWAY FACING NORTHBOUND ON FISHCREEK RD. NEAR 5528 FISHCREEK RD. UNIT #2 DID NOT POSSESS ANY LIGHTED HEADLIGHTS OR TAILLIGHTS. DUE TO THE LIGHT CONDITIONS, THE DRIVER OF UNIT #1 HAD DIFFICULTY SEEING UNIT #2. AS A RESULT, THE FRONT END OF UNIT #1 STRUCK THE REAR END OF UNIT #2.
