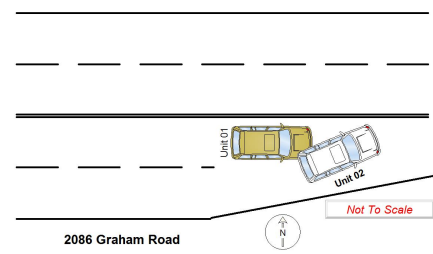

NARRATIVE

Unit 01 was traveling eastbound on Graham Road in front of 2086 Graham Road, in the inside lane. Unit 02 was traveling eastbound on Graham Road in the curb lane, next to Unit 01. The curb lane ends near this location, requiring drivers to merge to the left. Unit 02 failed to yield to Unit 01 and merged into the left lane. This caused Unit 01 to strike Unit 02.

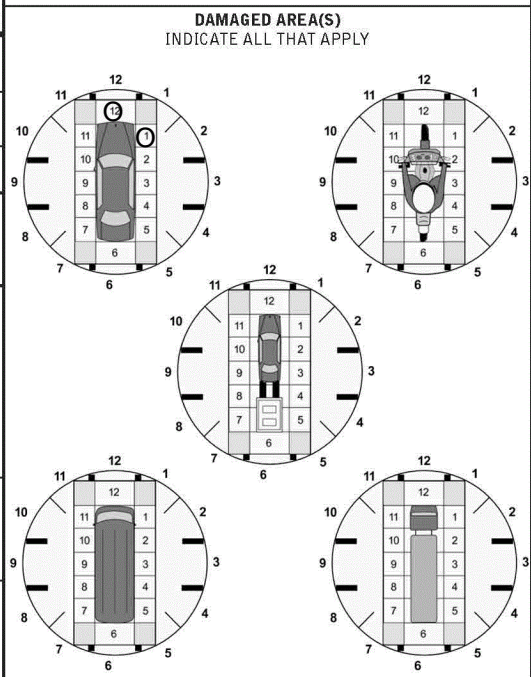

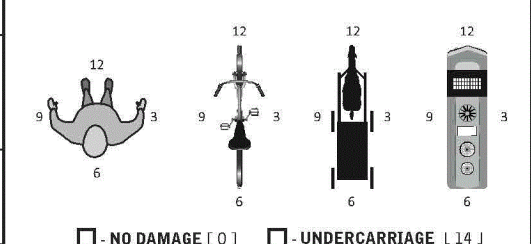

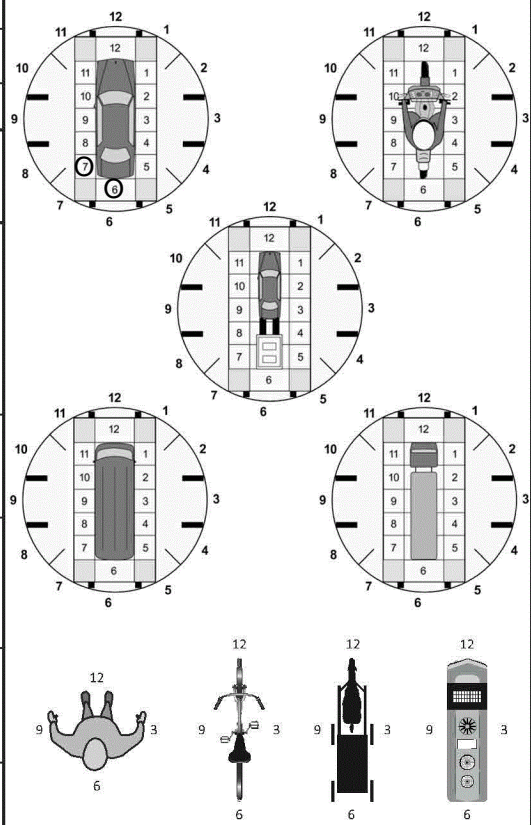
