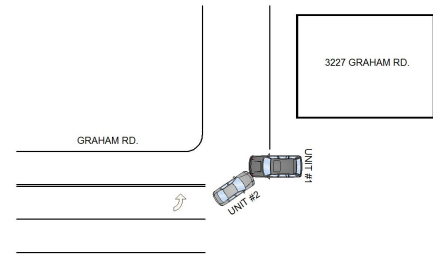
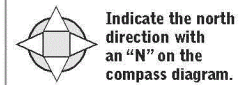

AS A RESULT, THE FRONT END OF UNIT #2 STRUCK THE FRONT END OF UNIT #1.

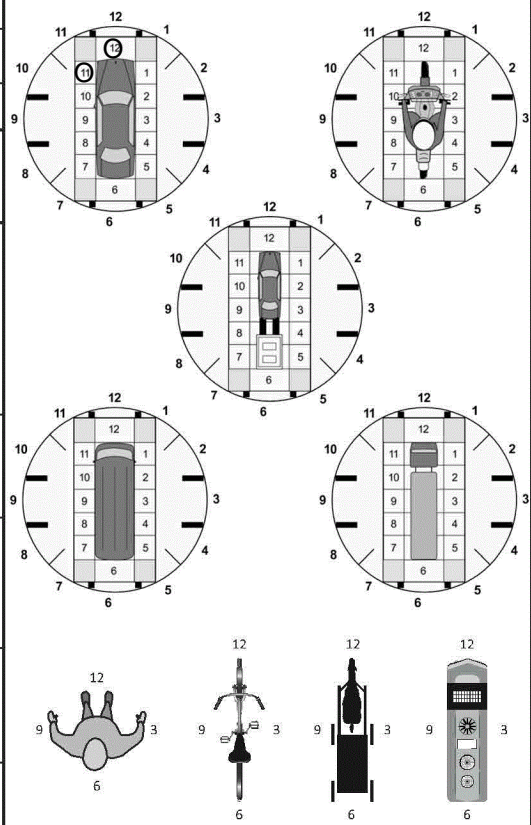
