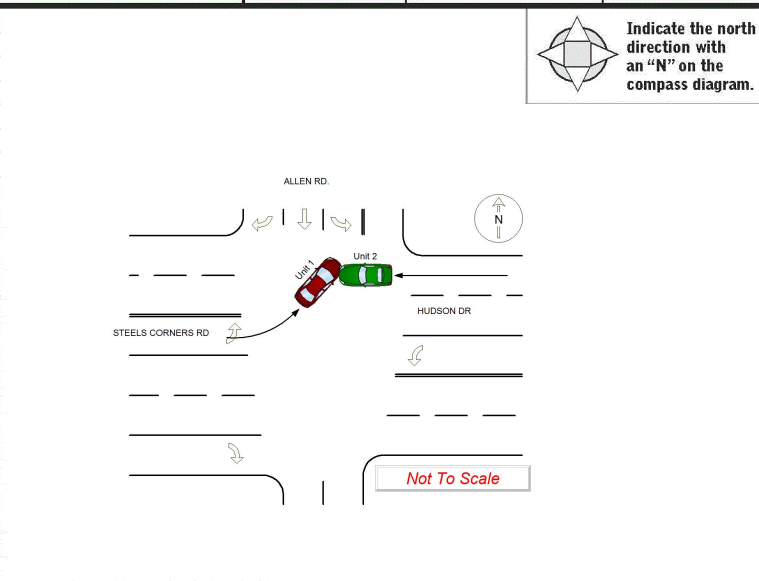

UNIT 1 WAS STOPPED IN THE INTERSECTION OF HUDSON DRIVE AND ALLEN ROAD WAITING TO TURN NORTH ONTO ALLEN ROAD. THE TRAFFIC LIGHT TURNED RED AND UNIT 1 BEGAN TURNING TO CLEAR THE INTERSECTION. UNIT 2 WAS TRAVELING SOUTHBOUND ON HUDSON DRIVE, RAN THE RED TRAFFIC SIGNAL AND STRUCK UNIT 1.
