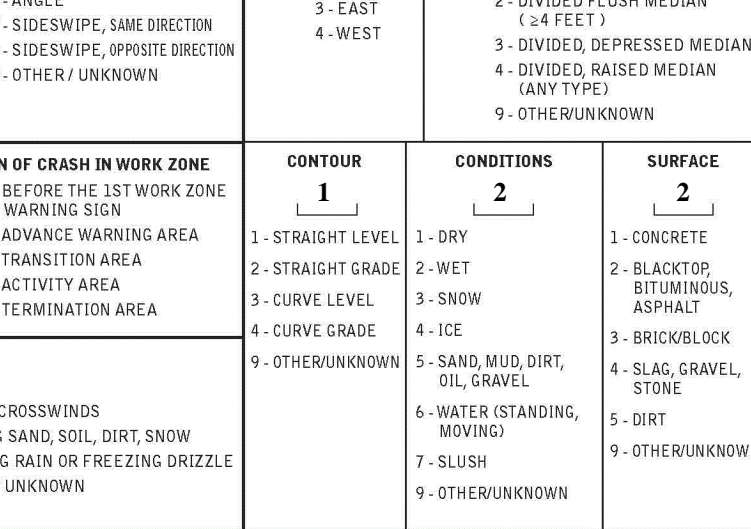

NARRATIVE

Unit #1 was southbound on Fishcreek Rd. continuing straight through the Stow Rd. intersection. Unit #2 was north on Fishcreek Rd. turning left (south) onto Stow Rd. Unit #2 failed to yield when turning left. Unit #1 struck unit #2. An employee at Circle K gas station stated the crash had been captured on their video surveillance. Police reviewed the video on scene and included a copy in the case file.
