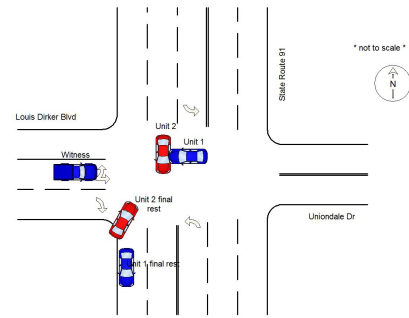

NARRATIVE
Unit #1 was stopped on Uniondale Dr. facing west at the red light of State Route 91. Unit #2 was southbound on State Route 91 in the left lane. According to an independent witness who was on Louis Dirker Blvd, the driver of unit #2 ran the red light as unit #1 attempted to go west through the intersection. The witness stated her eastbound light turned green and her husband started to proceed east and stopped as unit #2 ran the red light. Unit #2 spun around after the collision coming to final rest facing north.

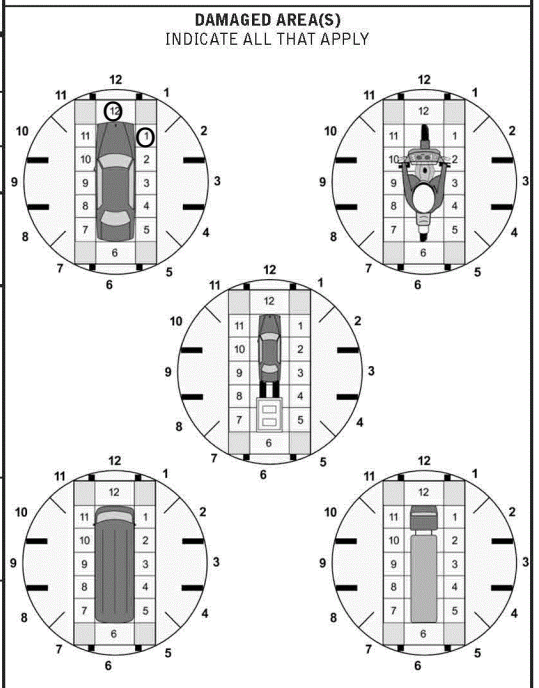

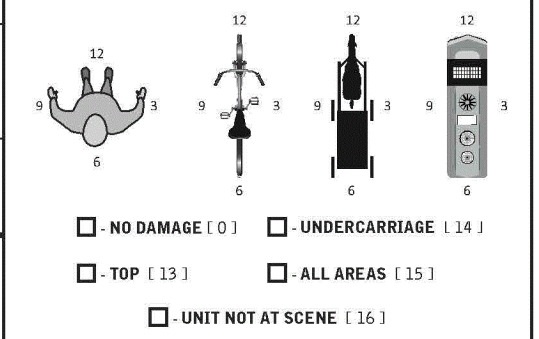
