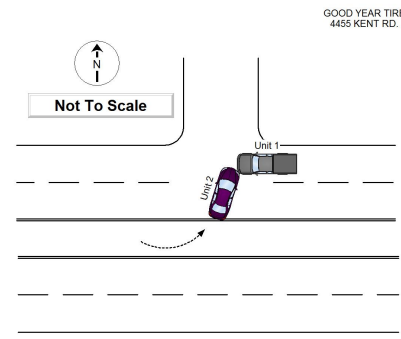

UNIT #2 STARTED TO TURN NORTH INTO GOOD YEAR TIRE AT 4455 KENT RD. BUT DID NOT YIELD TO UNIT #1 WHO HAD THE RIGHT OF WAY GOING WESTBOUND IN THE CURB LANE ON S.R. 59. BOTH VEHICLES COLLIDED.

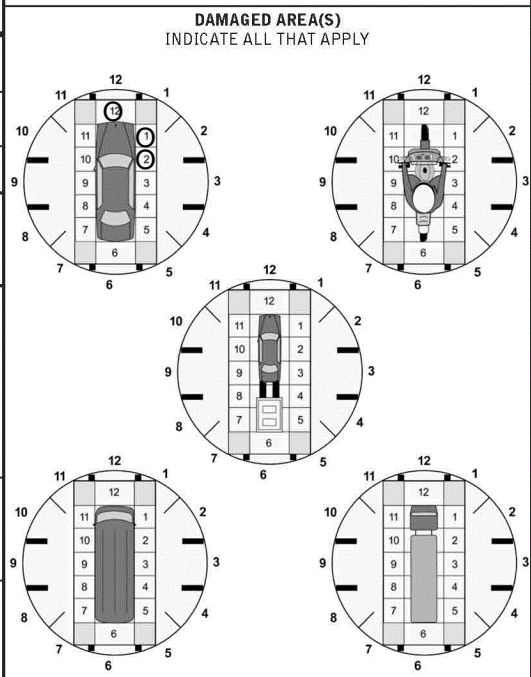
