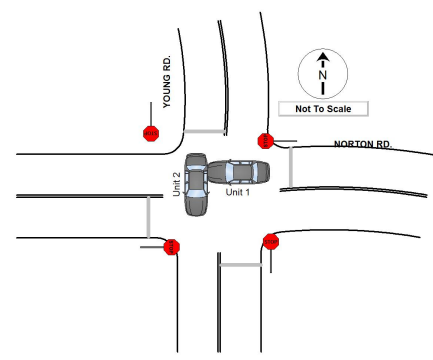

NARRATIVE
UNIT 1 STATED SHE WAS TRAVELING WEST ON NORTON AND STOPPED AT THE STOP SIGN FOR THE INTERSECTION OF NORTON AND YOUNG. UNIT 2 STATED SHE WAS SOUTH ON YOUNG AND STOPPED AT THE STOP SIGN FOR THE INTERSECTION OF YOUNG & NORTON. BOTH UNITS BELIEVED THEY STOPPED FIRST AND PROCEEDED THROUGH THE INTERSECTION AT THE SAME TIME, CAUSING UNIT #1 TO T-BONE UNIT #2. A NEARBY DOORBELL CAMERA CAPTURED THE COLLISION AND IT SHOWED THAT UNIT #1 ARRIVED AT THE STOP SIGN FIRST AND MADE A FULL STOP.

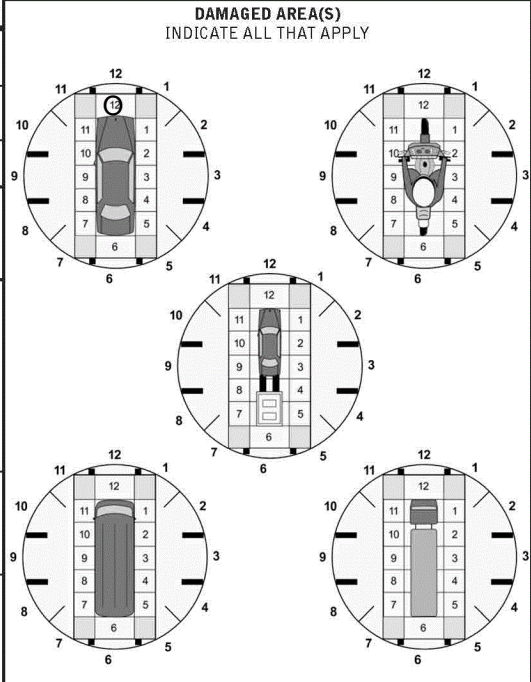
