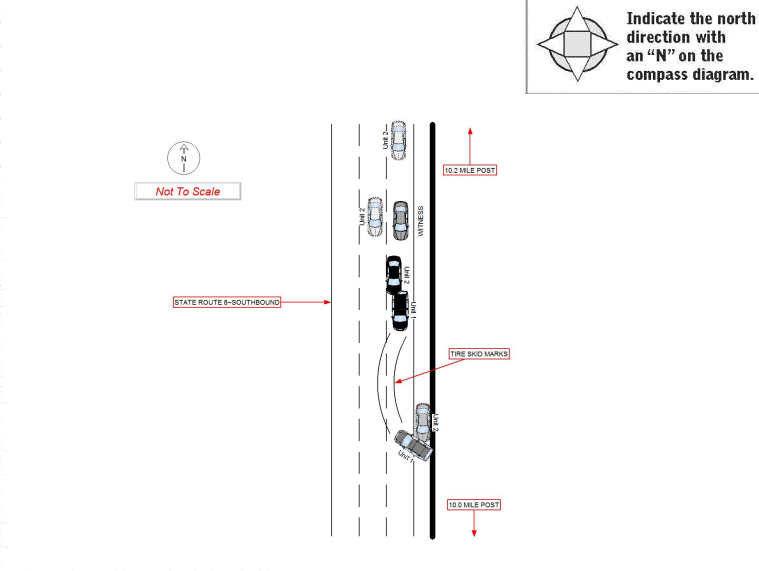

NARRATIVE
Both units were southbound on State Route 8. Unit #1 was in the left lane. Unit #2 was in the left lane, behind unit #1 and a witness, traveling at a high rate of speed. Unit #2 changed lanes to the middle lane to pass a witness. Unit #2 then changed lanes back into the left lane. Unit #2 struck the rear of unit #1 near the 10.2 mile post. The impact spun unit #1 around. Both units struck the concrete median where they came to rest. Unit #2 was arrested for OVI.
