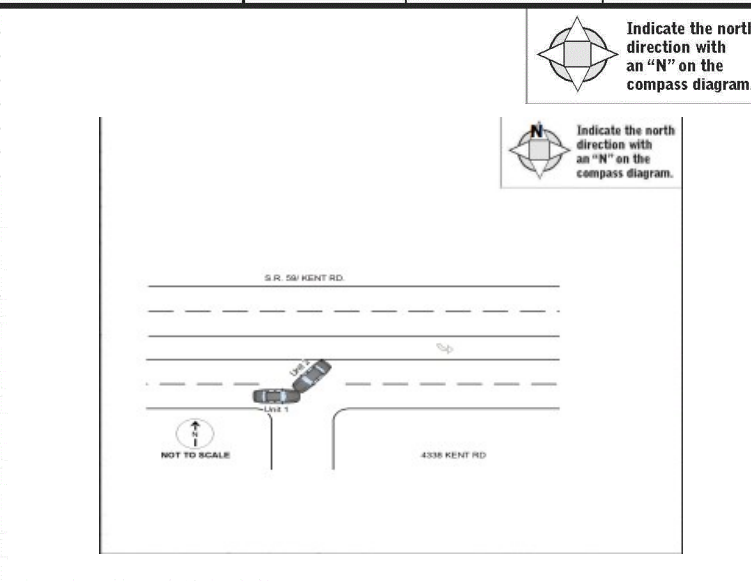

ANOTHER EASTBOUND MOTORIST STOPPED IN THE CENTER LANE TO WAVE UNIT #2 ON TO COMPLETE A TURN. UNIT #2 TURNED BUT DID NOT YIELD TO UNIT #1 WHO HAD THE RIGHT OF WAY IN THE CURB LANE AND THE VEHICLES COLLIDED.**
