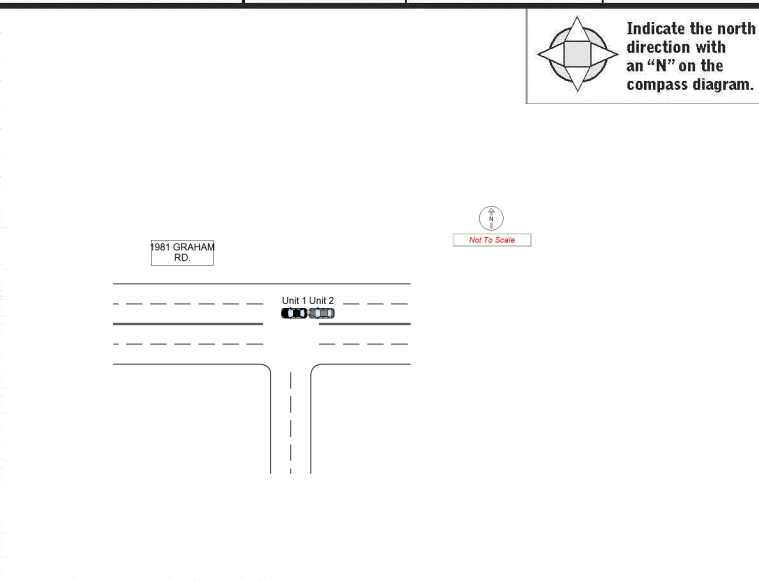

UNIT 1 AND UNIT 2 WERE IN THE LEFT LANE TRAVELING WEST ON GRAHAM RD. UNIT 2 WAS DIRECTLY BEHIND UNIT 1. UNIT 1 WAS SLOWING DOWN FOR THE SCHOOL ZONE. UNIT 2 FAILED TO KEEP AN ASSURED CLEAR DISTANCE AHEAD, CAUSING THEM TO STRIKE UNIT 1.

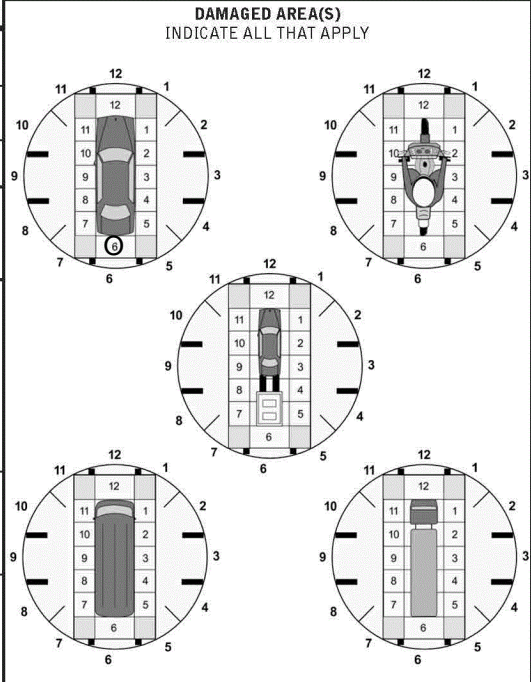
