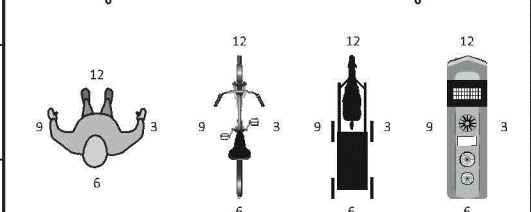

The seizure/medical issue came on so quickly I didn't get a chance to. The next thing I remember is driving around the back roads of Stow/Kent/Strathtsboro. When I came to, I was still fuzzy but I called my husband at 8:18 and used my GPS to find my way back to where I was certain I could get home and my brain was clear. I called him again at 8:35 pm when I realized my driver side mirror was gone and I may have hit something. By that point I was on Rt. 5 in Ravenna and had no clue where or what I may have hit. When I got home he called his mom and his parents drove to see if they could find what happened and it was right at the stop sign at the intersection of Young and Call Rd. I have no recollection of hitting anything.
