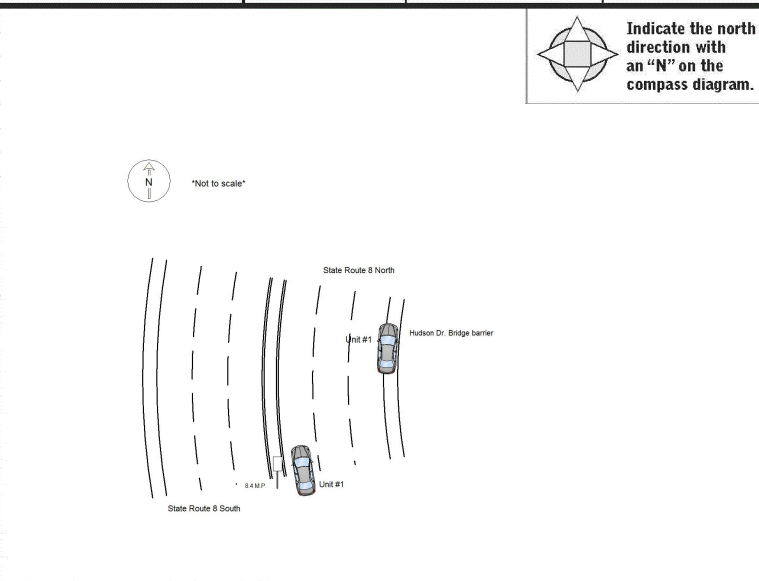

NARRATIVE

Unit #1 was northbound on State Route 8 North in the left lane. Unit #1's driver stated she had some type of malfunction (possibly a tie rod) in her right front wheel well near the 8.4 mile post lost and lost control of her vehicle. She slid across all three lanes and went off the right side of the road. She struck the concrete bridge barrier to Hudson Dr. which disabled her car. She complained of a head injury but declined EMS.
