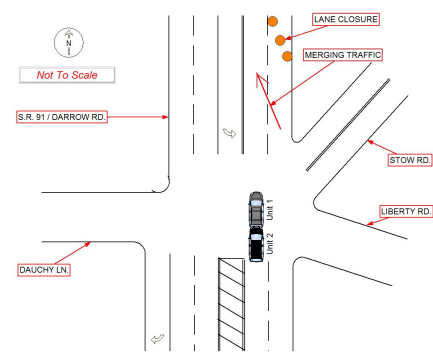
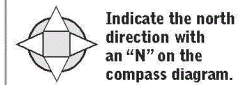

Unit #1 stopped due to a line of merging traffic. Unit #2 failed to maintain assured clear distance ahead and struck the rear of unit #1. OH-3 statements were declined.

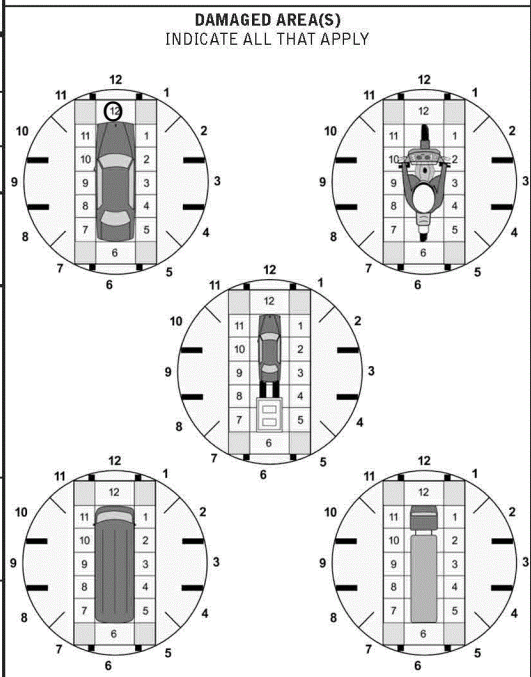

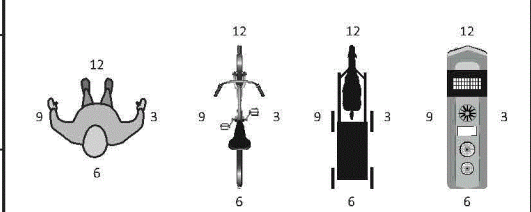
