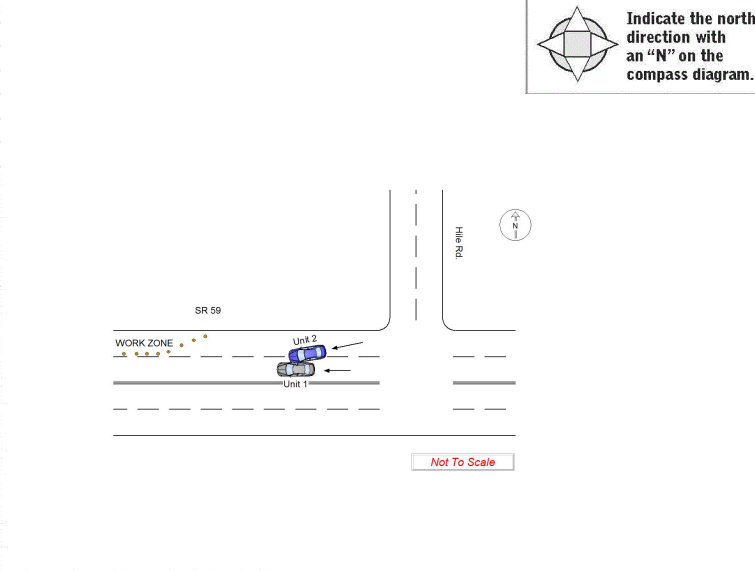

Unit 1 was traveling west on SR 59 passing Hile Rd. in the left lane. Unit 2 was traveling the same direction on SR 59 in the right lane next to Unit 1. Unit 2 began merging into the left lane without exercising due care to ascertain the movement could be made with reasonable safety, striking Unit 1 on the passenger side.

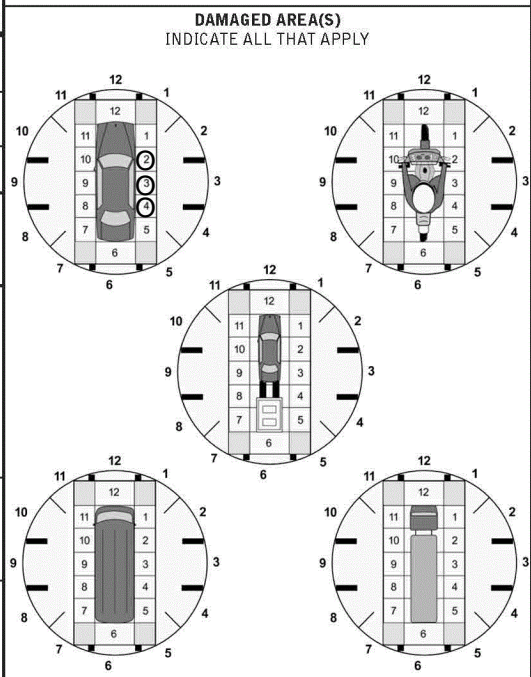

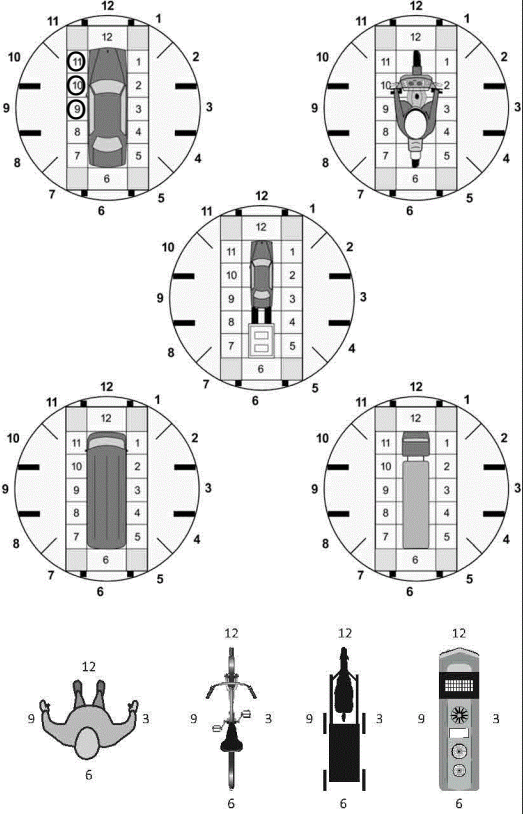
