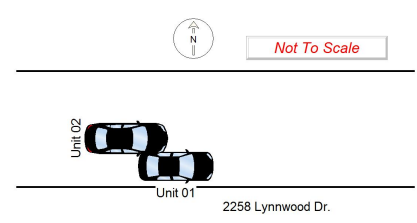

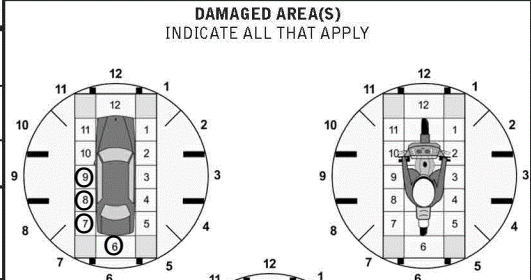

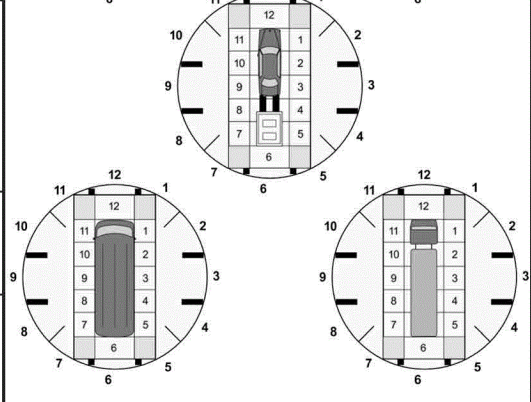

# OF TRAILING UNITS



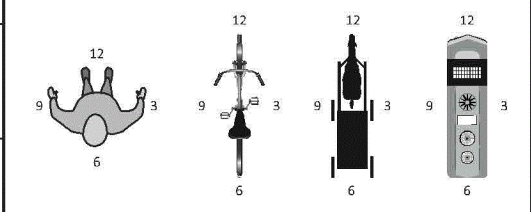

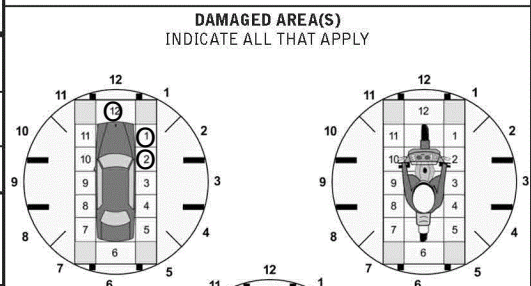

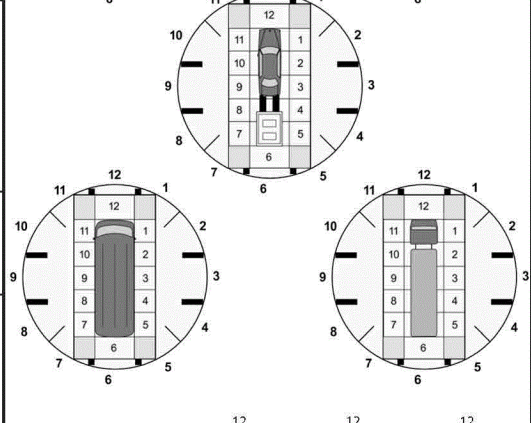

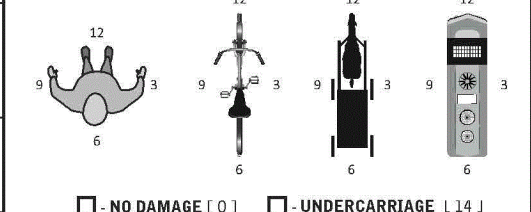
