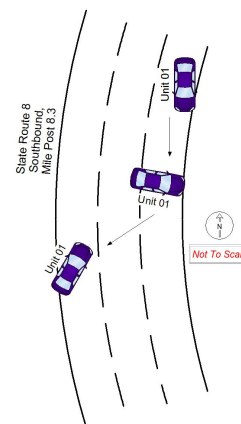
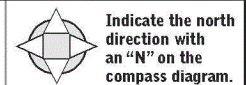

NARRATIVE

Unit 01 was traveling southbound on State Route 8 between E. Steels Corners Road, and Graham Road. A witness traveling 65 MPH was passed by Unit 01, in the left lane, at a high rate of speed. Unit 01 failed to maintain control and struck the median, causing it to spin, and became disabled. Unit 01 was found to be under the influence and was subsequently arrested for OVI.

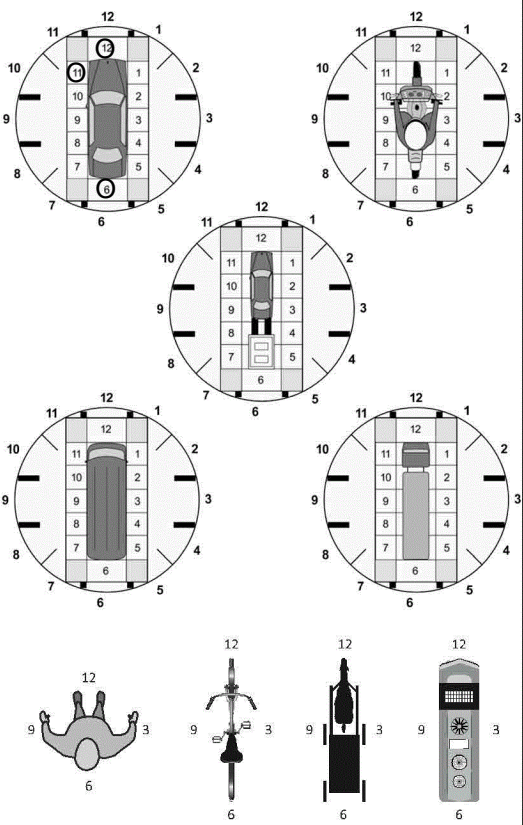
