

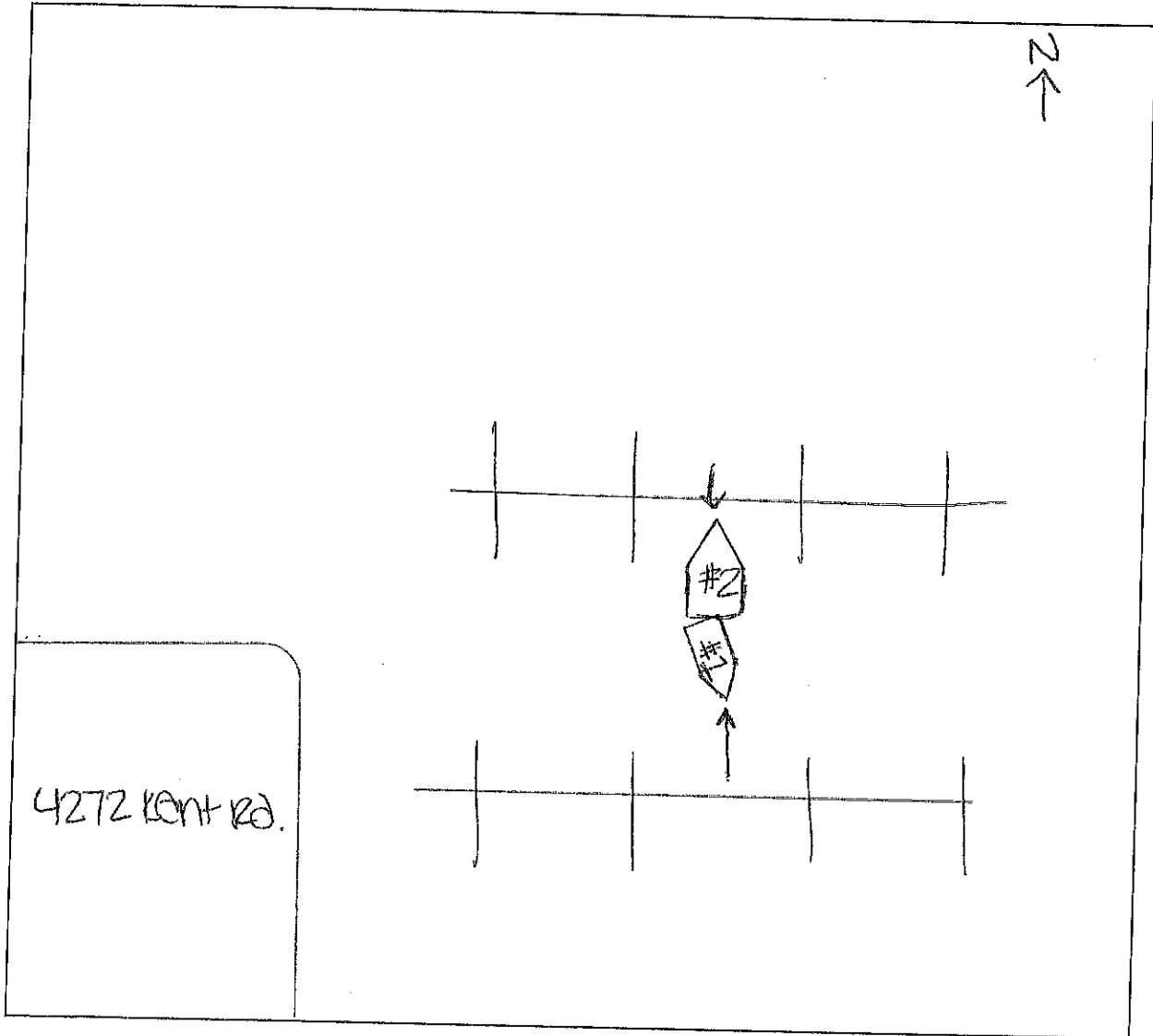

Parked at 2nd handi Cap Spot outside Old Navy Entrance. All seat belts worn and 3 kids in 3 car seats all security buckled. Finished errand returned to car, buckled seat belt. Placed car in reverse, looked in 3 mirrors and camera. Noticed no objects and started to reverse. Light pressure on gas. Got 1/2 car length out of spot where felt impact. Looked back and saw Ford. Pulled car back into spot to secure safety and got out to ~~over~~ assess situation. All passengers in both vehicles said they were fine and reported no ~~injuries~~ injuries. Minimal damage to Ford on ~~rear~~ rear driver side tail light. My Chrysler van has significant damage around bumper and license plate area. Pictures were taken on my cell of both vehicles.

Time of accident was around 1:20pm on March 24, 2022.
