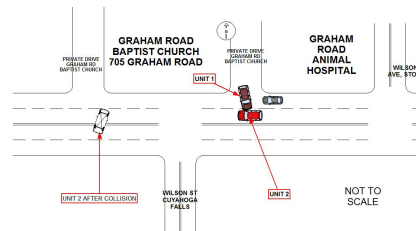
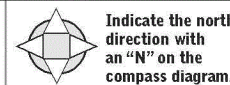

UNIT 1 WAS ATTEMPTING TO EXIT A PRIVATE DRIVEWAY AND PROCEED EB ON GRAHAM RD. UNIT 2 WAS WB ON GRAHAM RD IN THE INSIDE LANE. UNIT 1 WAS WAIVED OUT BY TRAFFIC THAT HAD STOPPED IN THE CURB LANE. UNIT 1 DID NOT YIELD TO UNIT 2 AND STRUCK UNIT 2. UNIT 2 WAS SPUN ONTO ITS ROOF AS A RESULT OF THE COLLISION.



