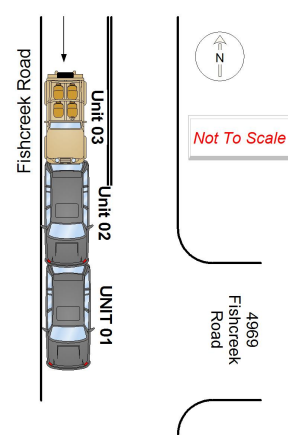
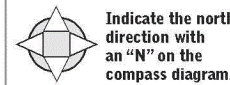

Unit 01 was traveling southbound on Fishcreek Road, stopped in traffic near 4969 Fishcreek Road. Unit 02 was traveling directly behind Unit 01 and was coming to a stop. Unit 03 was traveling directly behind unit 02. Unit 03 failed to maintain assured clear distance ahead and struck Unit 02, which caused Unit 02 to strike Unit 01.

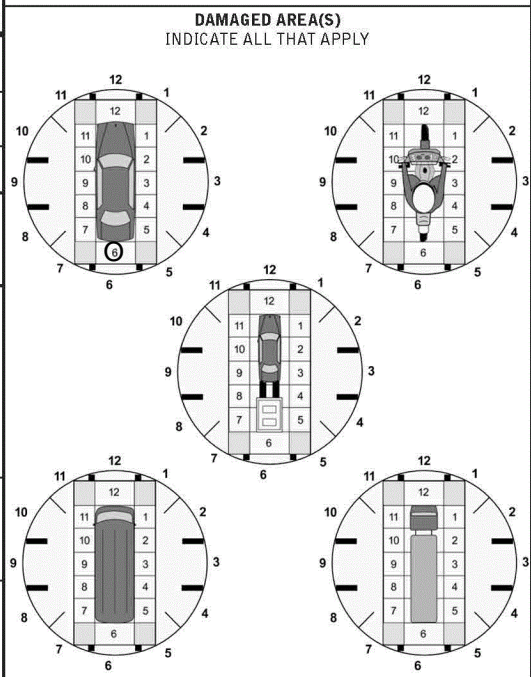

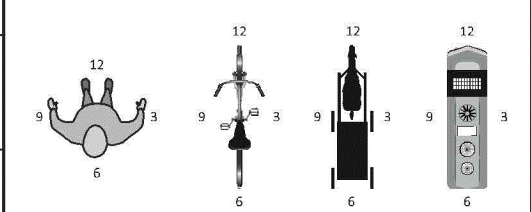

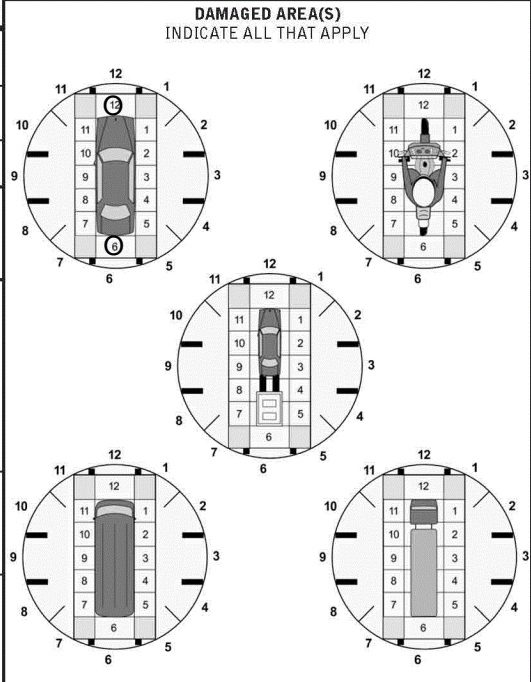
