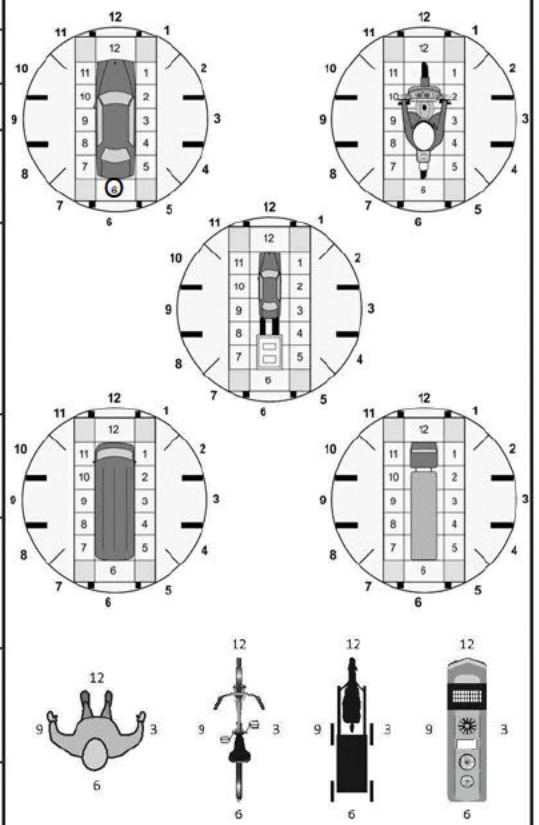

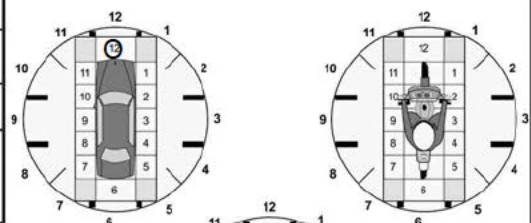

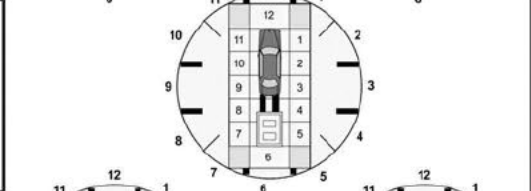

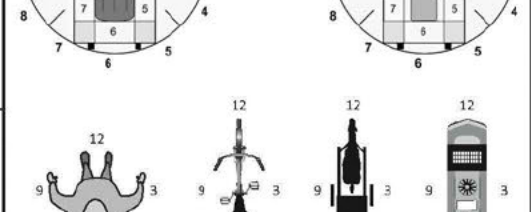

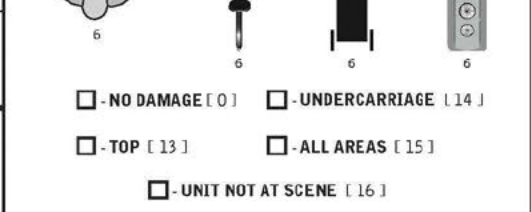

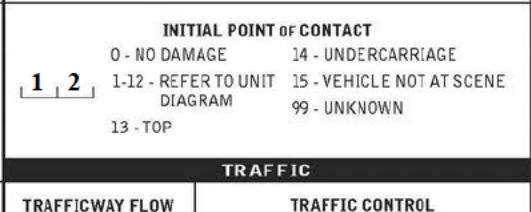
NON-MOTORIST LOCATION AT IMPACT, ACTION 3, CONTRIBUTING CIRCUMSTANCES 08



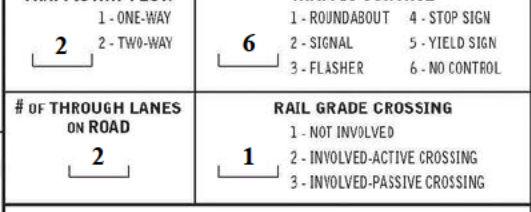
SEQUENCE OF EVENTS, EVENTS, COLLISION WITH FIXED OBJECT - STRUCK



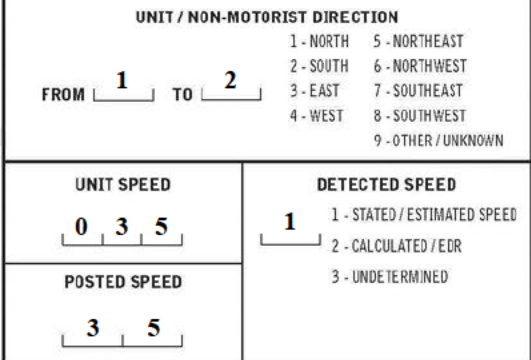
