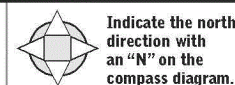

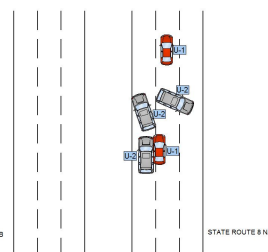

UNIT 2 WAS N/B ON STATE ROUTE 8 IN THE LEFT LANE. UNIT 1 WAS IN THE RIGHT LANE AND FAILED TO STAY IN THEIR MARKED LANE AND MADE CONTACT WITH UNIT 2'S PASSENGER SIDE. UNIT 2 LOST CONTROL AND HIT THE CONCRETE MEDIAN WITH THE FRONT OF HER VEHICLE. UNIT 1 CONTINUED ON N/B ON SR-8 WITHOUT STOPPING. UNIT 1 WAS DESCRIBED AS POSSIBLY BEING A RED DODGE CALIBER.

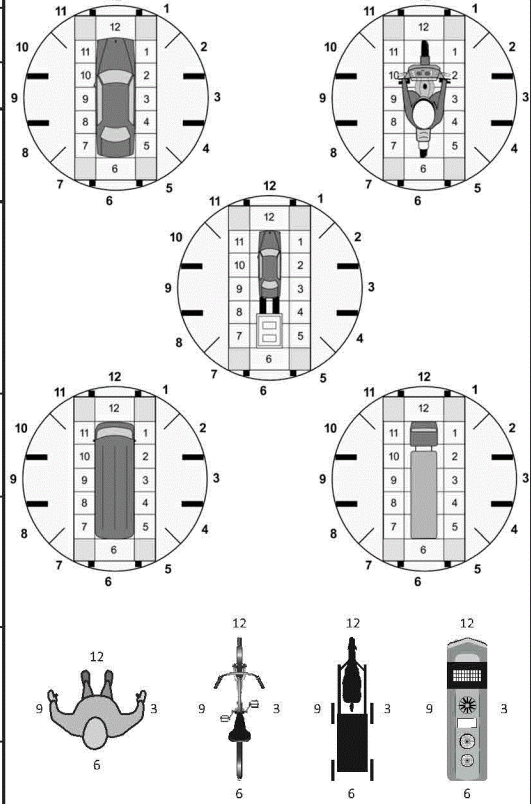
