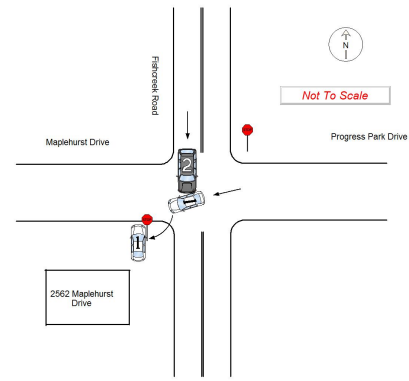

Unit #2 was traveling south bound on Fishcreek Road and approaching the intersection with Maplehurst Drive. Unit #1 started to enter the intersection to travel west bound on Maplehurst Drive and failed to yield right of way to Unit #2, then being struck by Unit #2. Unit #1 then drove off the road left after being struck , into the yard of 2562 Maplehurst Drive. Unit #1 also knocked over the stop sign in front of the stated residence. No injuries reported. Ofc. 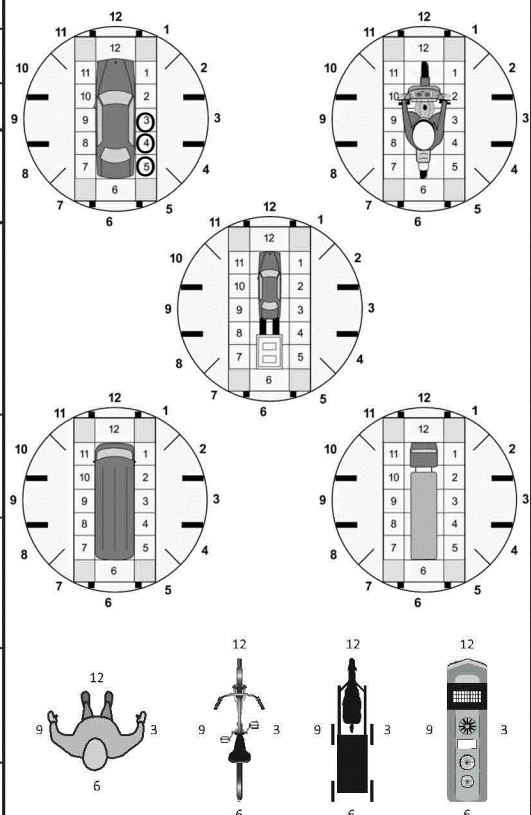
