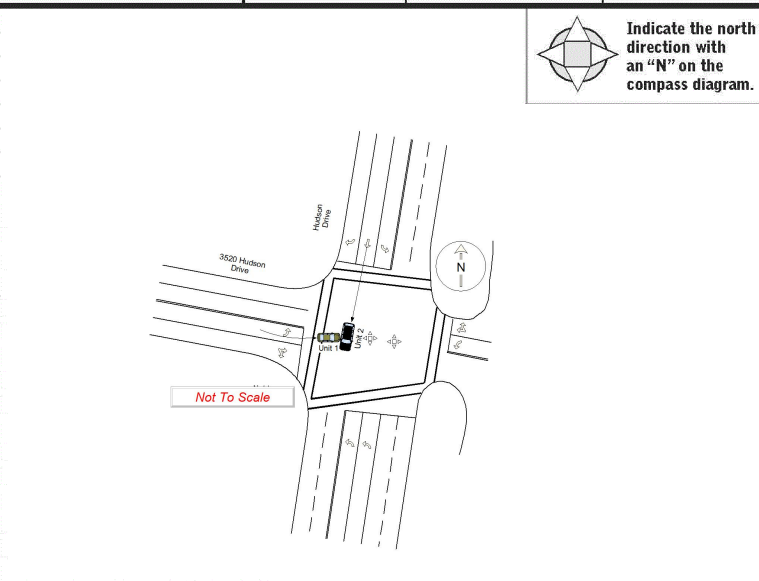

UNIT 1 STRUCK UNIT 2 IN THE INTERSECTION CAUSING MINOR DAMAGE. UNABLE TO DETERMINE WHO HAD THE GREEN LIGHT DUE TO CONFLICTING STATEMENTS.
