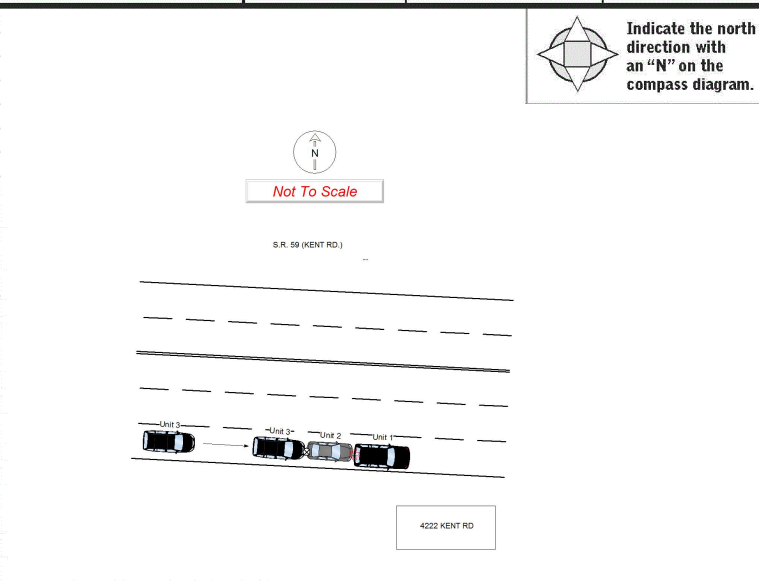

UNIT 1 WAS STOPPED AT THE LIGHT IN FRONT OF 4222 KENT RD. UNIT 2 WAS DIRECTLY BEHIND UNIT 1. UNIT 1 AND UNIT 2 WERE IN THE CURB LANE, TRAVELING EAST ON KENT RD. UNIT 3 WAS TRAVELING BEHIND UNITS 1 AND 2. UNIT 3 FAILED TO KEEP AN ASSURED CLEAR DISTANCE AHEAD AND STRUCK UNIT 2, CAUSING UNIT 2 TO STRIKE UNIT 1.

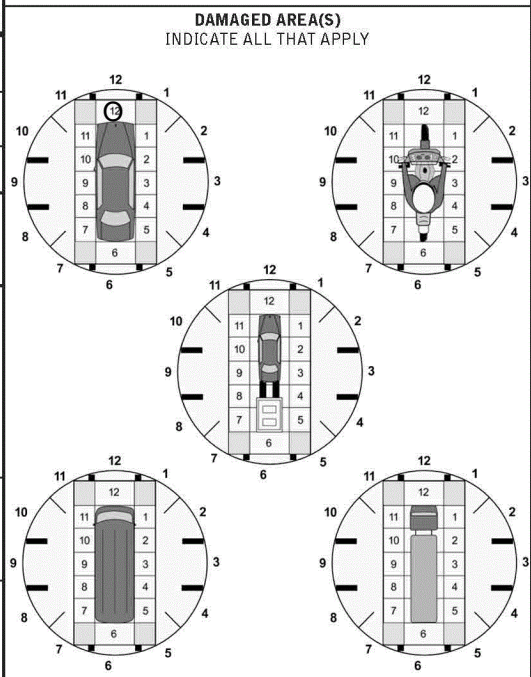

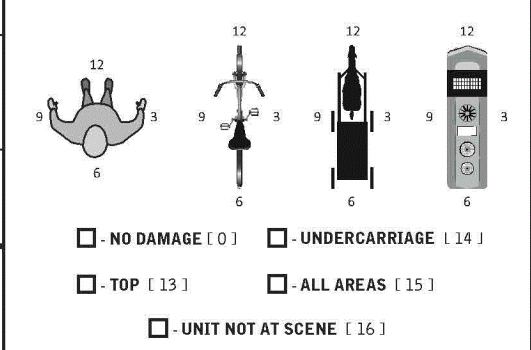
