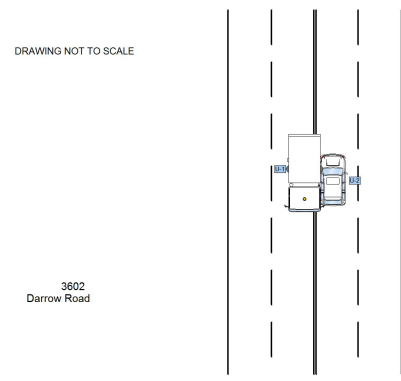

Unit-1 was traveling south-bound on Darrow Road in the left lane and unit-2 was headed north-bound on Darrow Road in the left lane. Unit-1 reached down to grab his drink, took his eyes off of the road and drove slightly left of center. Unit-1's rear section of his truck struck the driver's side of unit-2 and damaged much of the driver's side of unit-2.
