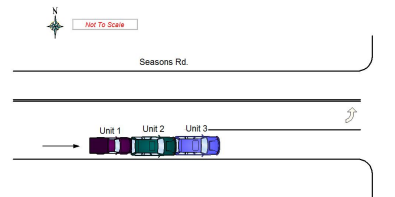
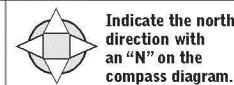

**Unit 3 was at a stop in traffic on Seasons Rd. traveling eastbound at the intersection with Hudson Rd. Unit 2 was traveling directly behind Unit 3. Unit 1 was traveling eastbound on Seasons Rd. directly behind Unit 2 and failed to maintain assured clear distance ahead. Unit 1 caused Unit 2 to strike Unit 3. All three Units came to rest after impact.**
