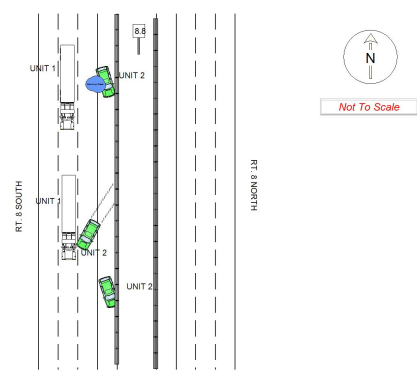

Unit 1 and Unit 2 were traveling South on Rt. 8 South. Unit 2 was in the far left lane and hydroplaned, losing control and striking the concrete barrier. Unit 2 then struck Unit 1, who was traveling in the middle lane. Unit 2 then struck the concrete barrier again after striking Unit 1. Both Units filled out OH-3s.
