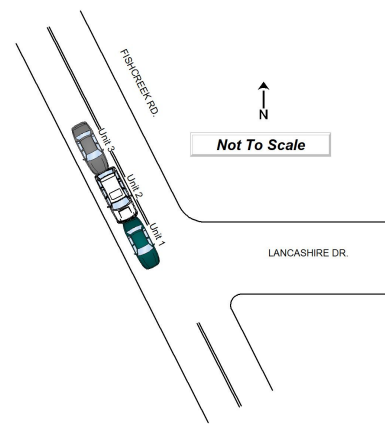

UNIT #1 WAS STOPPED IN TRAFFIC IN THE SOUTHBOUND LANE ON FISHCREEK RD. WAITING FOR TRAFFIC TO PASS NORTHBOUND TO MAKE A LEFT TURN ONTO LANCASHIRE DR. UNIT #2 CAME TO A SUDDEN STOP DIRECTLY BEHIND UNIT #1. UNIT #3 DID NOT ASSURE CLEAR DISTANCE AHEAD TO ACCOMODATE THE SUDDEN STOP AND REAR ENDED UNIT #2. THE IMPACT CAUSED UNIT #2 TO REAR END UNIT #1.

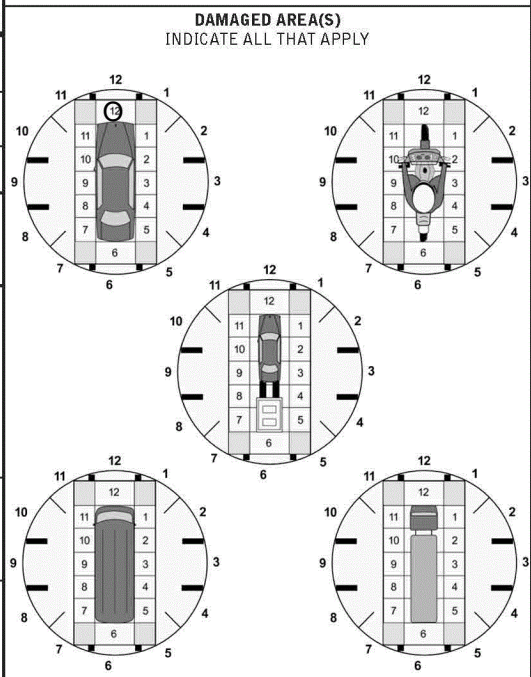

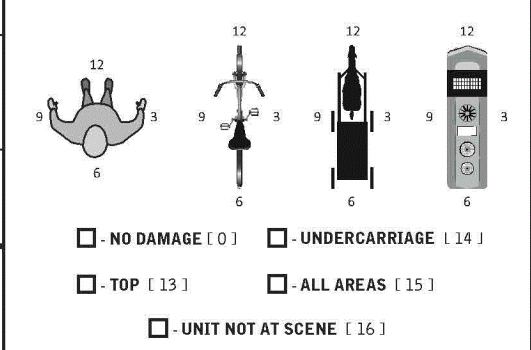
