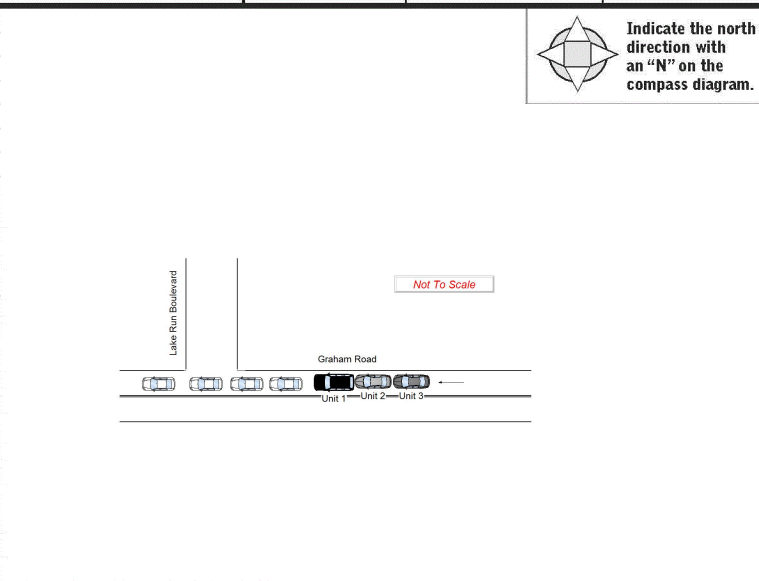

NARRATIVE

Unit #1 was eastbound on Graham Road, stopped in traffic near Lake Run Boulevard. Unit #2 was stopped directly behind Unit #1. Unit #3 was traveling eastbound directly behind Unit #2. Unit #3 failed to maintain an assured clear distance ahead, striking Unit #2 in the rear. Unit #2 was then pushed into the rear of Unit #1. The drivers of Unit #2 and Unit #3 did not wish to make a written statement (OH-3).
