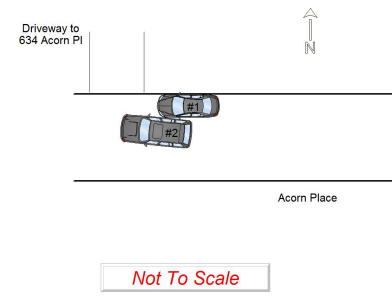
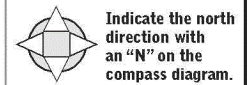

Unit #2 was eastbound on Acorn Pl passing to the left of numerous cars parked on the south side of the roadway. Unit #2 stopped for an oncoming truck near Unit #1. Unit #2 then began to back up to give room for the oncoming truck. The right side of Unit #2 struck the front left of Unit #1. Unit #2 then pulled forward and again the right side of Unit #2 struck the front left of Unit #1.

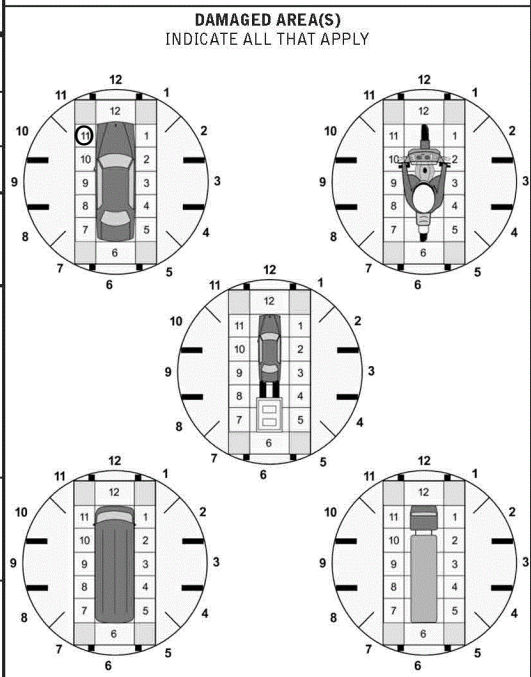

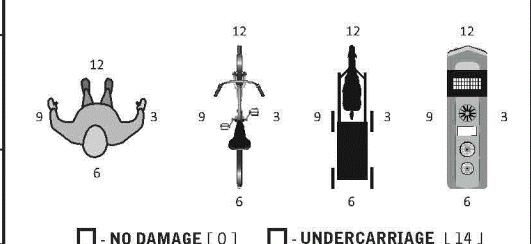
