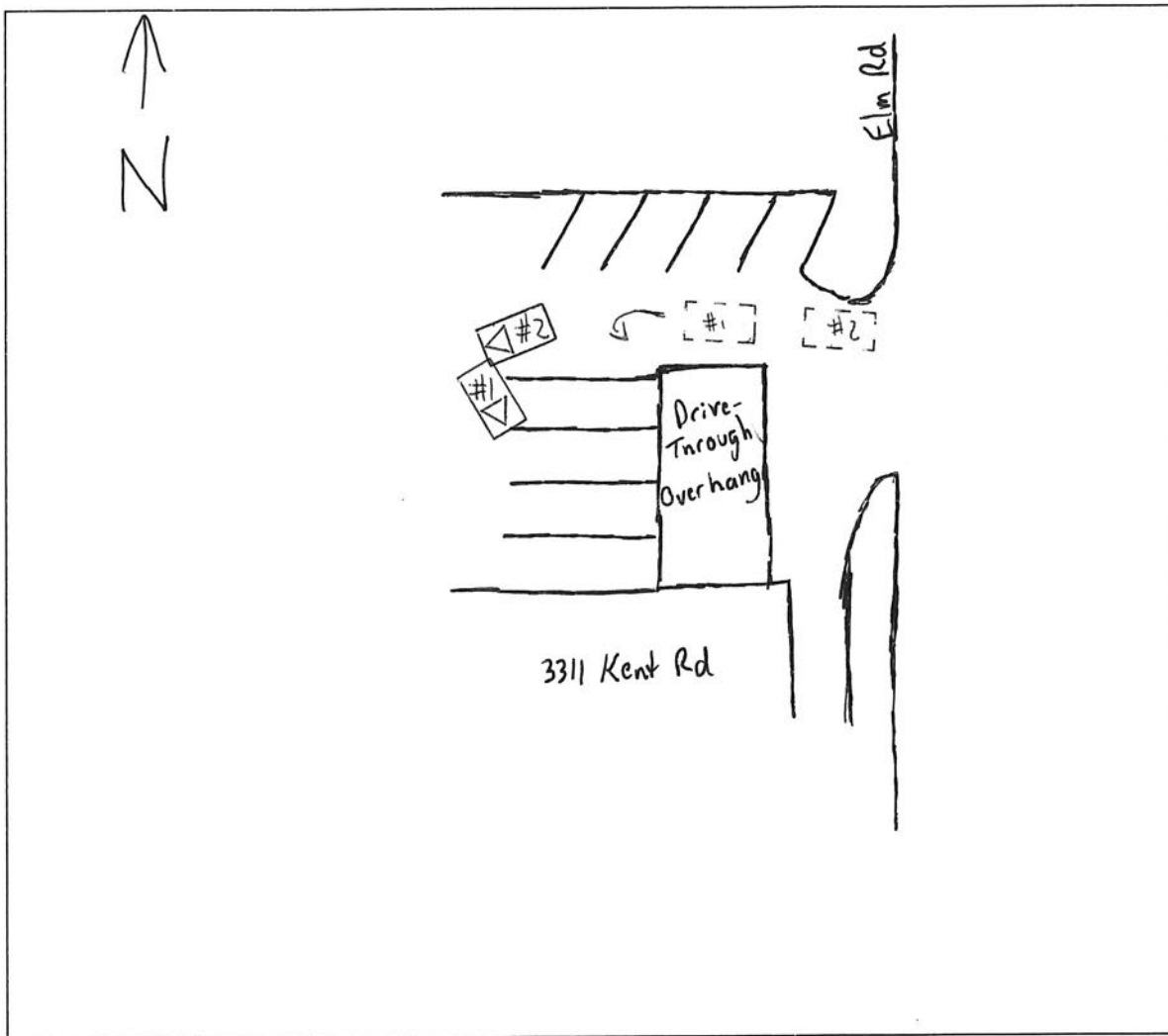

On Thursday December 29<sup>th</sup>, 2022 I was involved in a hit + run car accident. I was running errands before work. I noticed a car maneuvering on Graham Rd going east bound to follow behind me when I turned onto Elm Rd. From Elm Rd I turned into the Huntington (on Kent Rd.) and was turning into the ATM lane. As I was turning I saw the same car make a sharp fast turn to deliberately hit my car. The way he drove into me was not an accident, it seemed intentional because he seemed to have slightly speed up + turn to hit me. There was a male with short hair + glasses (from what I saw in my rearview mirror) driving a white sedan. I couldn't see what kind of car or the license plate because the car was dirty and he drove away very fast. At first I was startled and didn't know what to do but then I tried to follow him to get more info on the car. He left the Huntington parking lot, drove directly across Kent Rd. onto George Park Blvd. once traffic cleared I drove the same way, choosing to go towards CVS rather than back towards the apartments but did not see him. I drive a 2021 black Honda Civic EX license plate JKW2533
