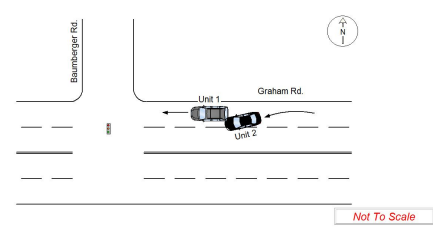
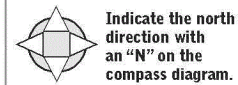

NARRATIVE  
**Unit 1 was traveling west on Graham Rd. approaching Baumberger Rd. in the right lane. Unit 2 was traveling directly behind Unit 1. As Unit 1 slowed to make a right turn onto Baumberger Rd. Unit 2 attempted to change lanes to pass Unit 1. Unit 2 failed to maintain an assured clear distance ahead, striking Unit 1. Unit 2 left the scene of the accident and did not immediately report it. With the help of witnesses, the driver and vehicle of Unit 2 were located shortly after the accident.**



