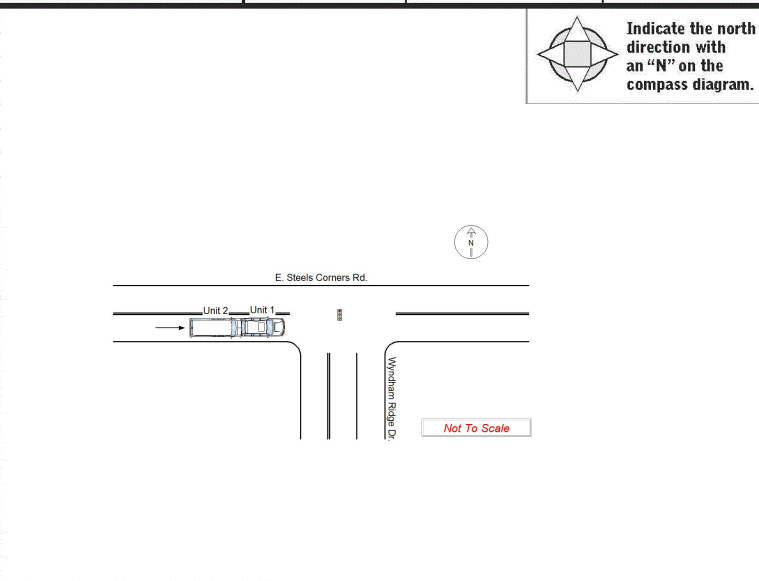

NARRATIVE
Unit 1 was stopped at the traffic light traveling east on E. Steels Corners Rd. at Wyndham Ridge Dr. Unit 2 was traveling behind Unit 1 but had not reached the intersection yet. Before Unit 2 reached the intersection, the light turned green. As Unit 1 began to pull forward, Unit 2 attempted to slow down. But Unit 2 failed to maintain an assured clear distance ahead, striking Unit 1 in the rear.
