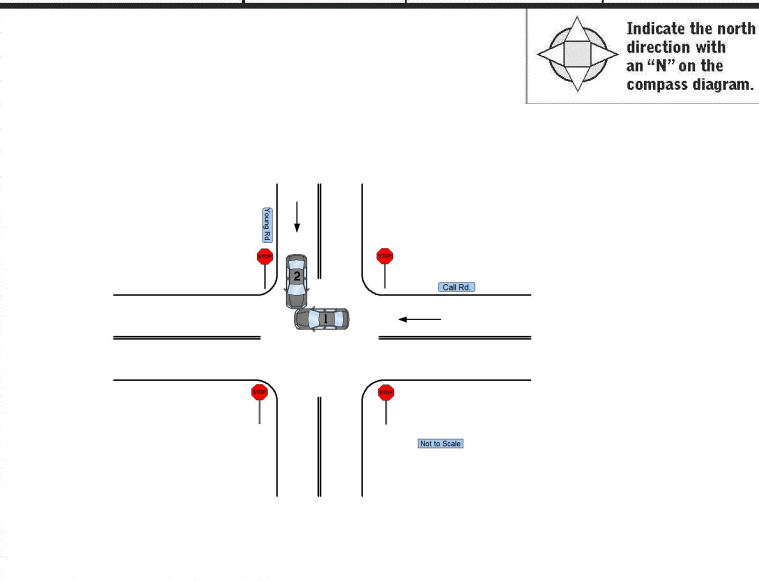

Unit 02 was traveling southbound on Young Road, approaching the stop sign at the intersection of Call Road. Unit 02 failed to stop at the stop sign and was struck by Unit 01. This incident was captured on a nearby video surveillance and reviewed by responding officers.**
