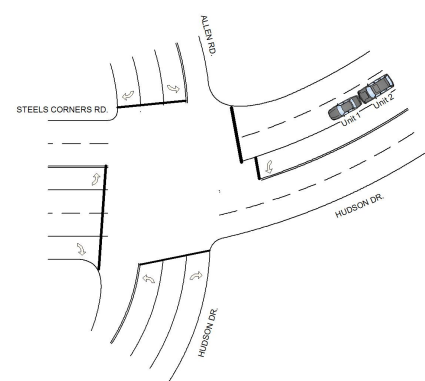

UNIT #1 WAS WEST ON HUDSON DR. IN THE MIDDLE STRAIGHT AWAY LANE STOPPED AT THE RED LIGHT FOR THE INTERSECTION OF HUDSON DR./ ALLEN RD./ STEELS CORNERS RD. UNIT #2 WAS STOPPED DIRECTLY BEHIND UNIT #1. THE DRIVER OF UNIT #2 TOOK HIS FOOT OFF THE BRAKE, CAUSING VEHICLE #2 TO DRIFT FORWARD WITHOUT HAVING CLEAR DISTANCE TO DO SO AND UNIT #2 REAR ENDED UNIT #1.

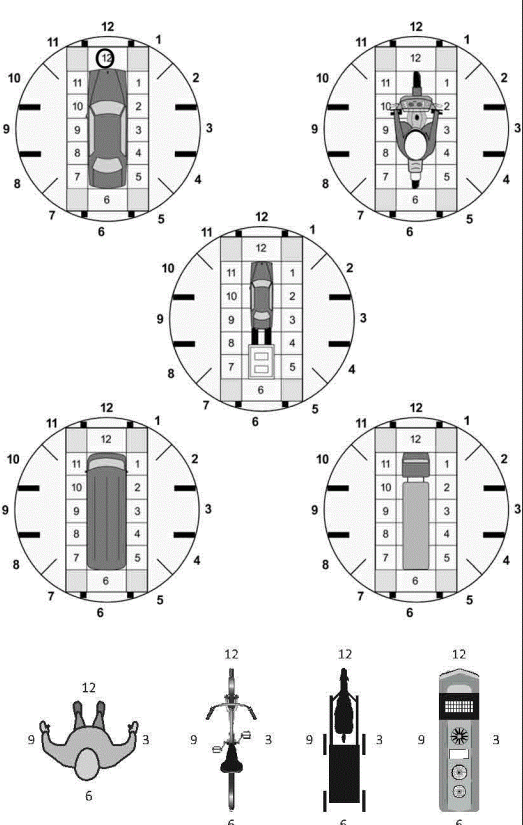
