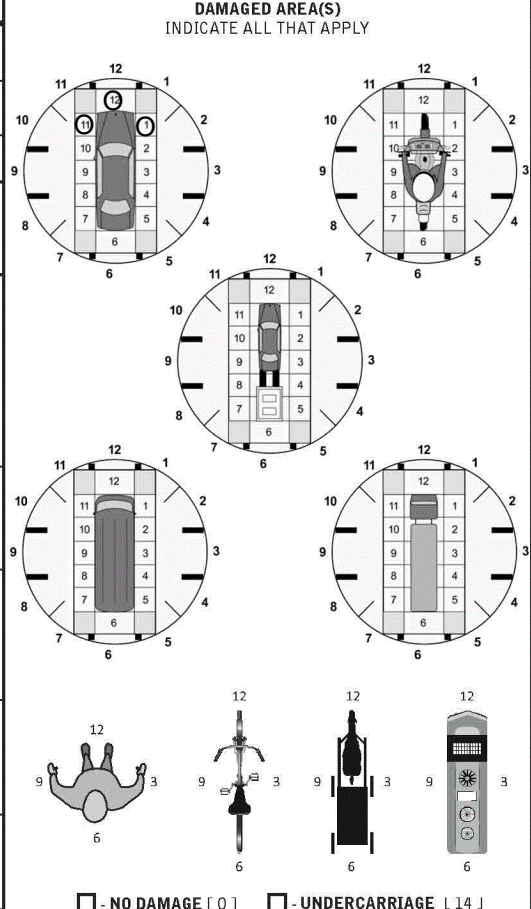

at 4:44p, I was stopped on Fishcreek road. A white Malibu rear ended me going about 30-35 mph. my car jolted forward and the car that hit me was stopped. I pulled off to the side of the road to call 911.
