DESCRIBE WHAT HAPPENED

On 2-22-23 at 1524 hours, Unit 1 reported a crash that occurred several hours earlier. Unit 1 stated he was w/B on Graham Road, near Englewood Drive, when he approached two utility vans and cones marking an area of lane closure in the right lane. Unit 1 stated he was in the left lane and a silver Town Car (with KY plate 547 ZJF) merged from the right/curb lane into his lane. The front passenger-side of Unit 1 collided with the rear driver-side of Unit 2. Unit 1 stated Unit 2 continued and did not stop. Unit 1 followed Unit 2 until Unit 2 exited SR 8 S/B on Tallmadge Ave (or a nearby exit) and Unit 1 continued on SR 8 S/B. I made contact with Unit 2 by telephone on 2-24-23. (over)

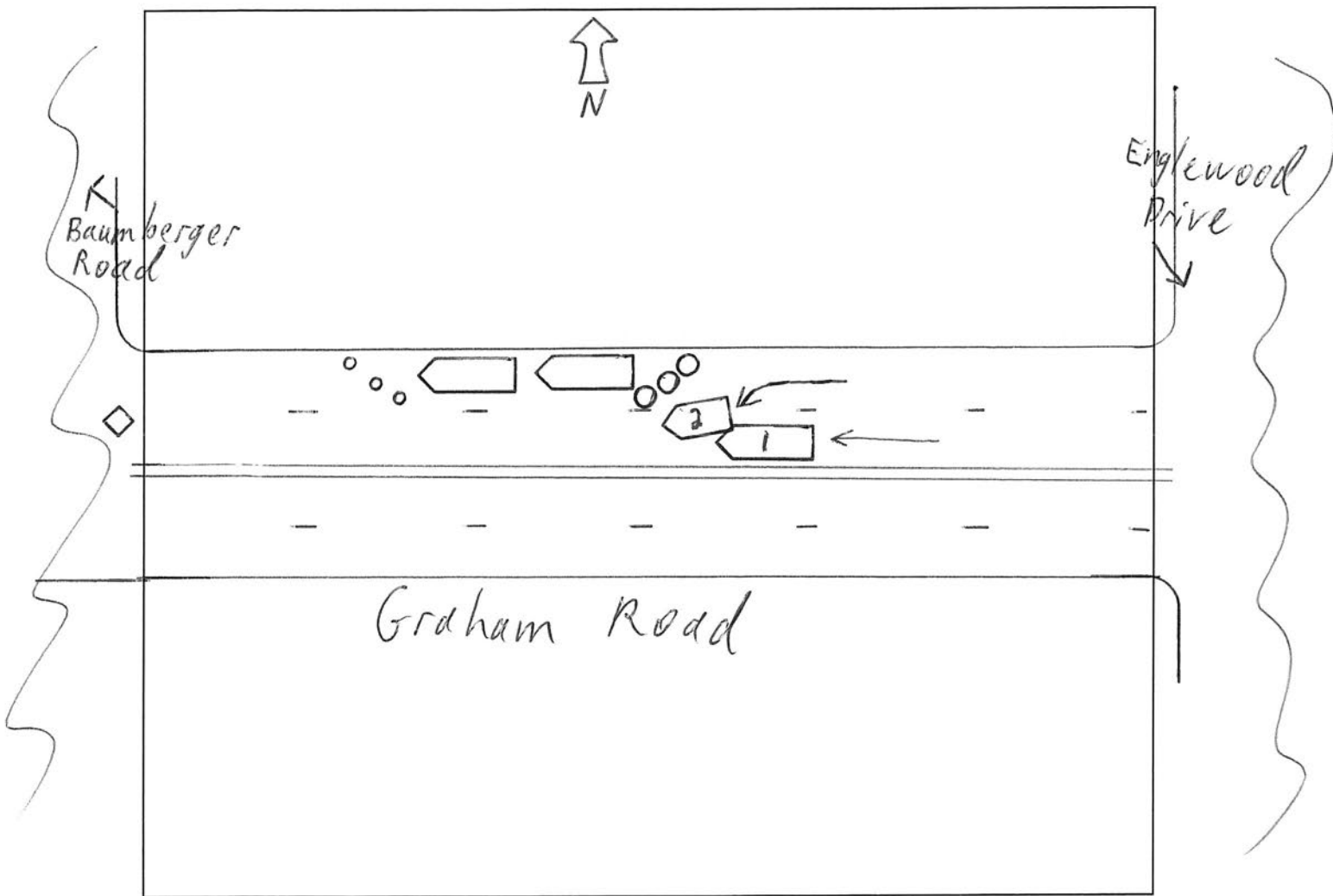

(cont'd) Unit 2 admitted to a similar version of events as provided by Unit 1. Unit 2 stated he did not stop because Unit 1 had driven very aggressively at the time of the crash and he "was concerned for (his) life." Unit 2 stated he and his wife were driving home to Kentucky after visiting his son's family in Stow, at the time of the crash. Unit 2 stated he was home (in Kentucky) as I spoke to him. He was advised to stop immediately if ever involved in another crash. Both units emailed me pictures of their insurance cards and the damage to their vehicles.
