Unit #3 was behind Unit #2. Unit #3 failed to maintain assured clear distance and struck Unit #2 from behind. This impact caused unit #2 to strike unit #1. 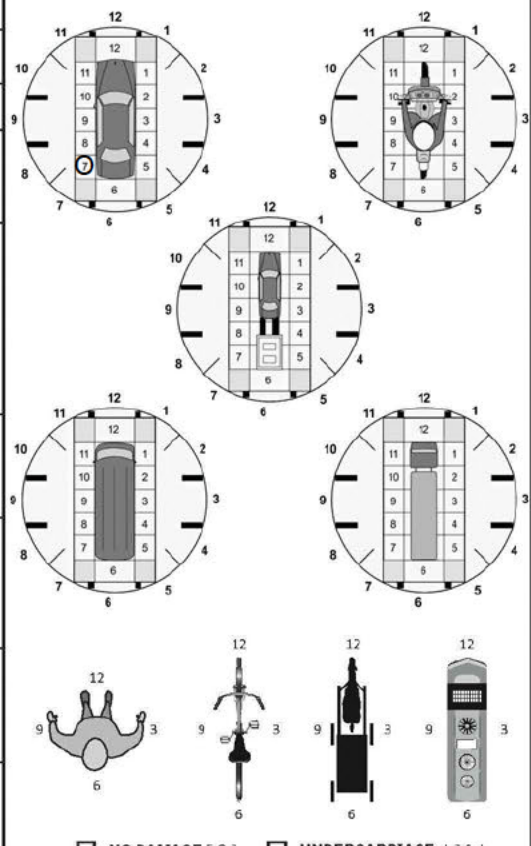
