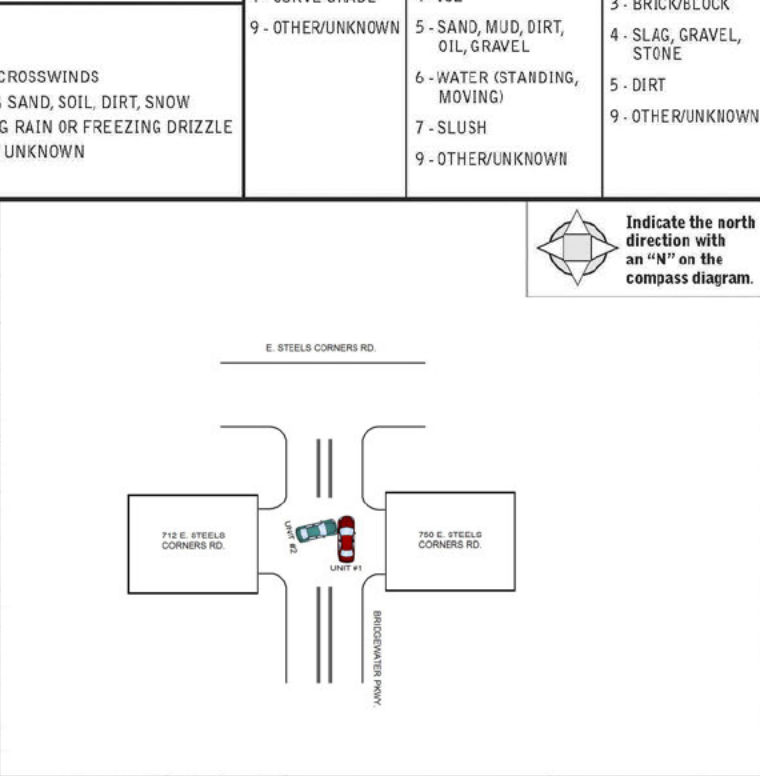

UNIT #1 WAS TRAVELING NORTHBOUND ON BRIDGEWATER PKWY. UNIT #2 HAD EXITED THE PARKING LOT OF 712 E. STEELS CORNERS RD. AND WAS ATTEMPTING TO MAKE A LEFT-TURN TO HEAD NORTHBOUND ON BRIDGEWATER PKWY. UNIT #2 FAILED TO YIELD TO THE RIGHT-OF-WAY OF UNIT #1. AS A RESULT, THE FRONT PASSENGER SIDE OF UNIT #2 STRUCK THE FRONT DRIVER SIDE OF UNIT #1.

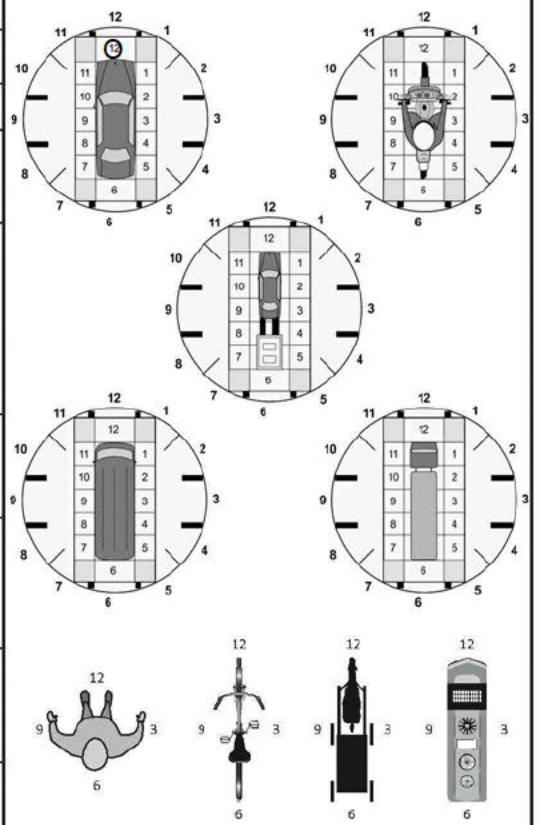
